1.2 Delete everything after the enacting clause and insert:

1.3 "Section 1. Minnesota Statutes 2020, section 45.25, is amended by adding a subdivision
1.4 to read:

1.5 Subd. 8a. **Live course.** "Live course" means any learning experience that is actively led
1.6 by an instructor, either online or in a classroom setting, that offers person-to-person, real-time
1.7 feedback. A live course offered online must:

1.8 (1) specify the minimum system requirements;

1.9 (2) provide encryption that ensures that all personal information, including the student's
1.10 name, address, and credit card number, cannot be read as it passes across the Internet;

1.11 (3) include technology to guarantee seat time;

1.12 (4) include the ability for the student to get technical support within a reasonable amount
1.13 of time;

1.14 (5) include a statement that the student's information will not be sold or distributed to
1.15 any third party without the prior written consent of the student. Taking the course does not
1.16 constitute consent; and

1.17 (6) include a process to authenticate the student's identity.

2.4 Subd. 12. **Proctor.** (a) "Proctor" means a ~~disinterested third party with no conflict of~~
2.5 interest person who (1) verifies a student's identity, and (2) processes an affidavit testifying
2.6 that the student received no outside assistance with the course or examination.

2.7 (b) A proctor must be 18 years of age or older. A proctor must not have a financial or
2.8 other conflict of interest with respect to a student's successful completion of the course or
2.9 the examination. A proctor must not be:

2.10 (1) a relative of the student;

2.11 (2) the student's supervisor at work;

2.12 (3) a person the student supervises at work; or

2.13 (4) a student who is completing the same course.

2.18 a series of courses and passing a graded, proctored examination.

2.19 Sec. 5. **[45.301] ON-DEMAND CONTINUING EDUCATION; REQUIREMENTS.**

2.20 Subdivision 1. **On-demand course requirements.** An on-demand continuing education
2.21 course offered online must:

2.22 (1) specify the minimum system requirements;

2.23 (2) provide encryption that ensures that all personal information, including the student's
2.24 name, address, and credit card number, cannot be read as it passes across the Internet;

2.25 (3) include technology to guarantee seat time;

2.26 (4) include a high level of interactivity;

2.27 (5) include graphics that reinforce the content;

2.28 (6) include the ability for the student to contact an instructor within a reasonable amount
2.29 of time;

3.1 (7) include the ability for the student to get technical support within a reasonable amount
3.2 of time;

3.3 (8) include a statement that the student's information will not be sold or distributed to
3.4 any third party without prior written consent of the student. Taking the course does not
3.5 constitute consent;

3.6 (9) be available 24 hours a day, seven days a week, excluding minimal down time for
3.7 updating and administration;

3.8 (10) provide viewing access to the online course at all times to the commissioner,
3.9 excluding minimal down time for updating and administration;

3.10 (11) include a process to authenticate the student's identity;

3.11 (12) inform the student and the commissioner how long after its purchase a course will

3.13 (13) inform the student that license education credit will not be awarded for taking the
3.14 course after it loses its status as an approved course;

3.15 (14) provide clear instructions on how to navigate through the course;

3.16 (15) provide automatic bookmarking at any point in the course;

3.17 (16) provide questions after each unit or chapter that must be answered before the student
3.18 can proceed to the next unit or chapter;

3.19 (17) include a reinforcement response when a quiz question is answered correctly;

3.20 (18) include a response when a quiz question is answered incorrectly;

3.21 (19) include a final examination;

3.22 (20) allow the student to go back and review any unit at any time, except during the final
3.23 examination;

3.24 (21) provide a course evaluation at the end of the course. At a minimum, the evaluation
3.25 must ask the student to report any difficulties caused by the online education delivery
3.26 method; and

3.27 (22) provide a completion certificate when the course and exam have been completed
3.28 and the provider has verified the completion. Electronic certificates are sufficient.

3.29 Subd. 2. **Final examination.** The final examination must be either an encrypted online
3.30 examination or a paper examination that is monitored by a proctor who certifies that the

4.4 Subd. 2. **Approval.** (a) ~~The commissioner must approve as a coordinator a person~~
4.5 ~~meeting one or more of the following criteria: at least three years of full-time experience~~
4.6 ~~in the administration of an education program during the five-year period immediately~~
4.7 ~~before the date of application, or a degree in education plus two years experience during~~
4.8 ~~the immediately preceding five-year period in one of the regulated industries for which~~
4.9 ~~courses are being approved, or a minimum of five years experience within the previous six~~
4.10 ~~years in the regulated industry for which courses are held.~~ A person applying for approval
4.11 as a course coordinator must:

4.12 (1) be qualified or have experience in the applicable subject matter of courses offered

4.21 Sec. 7. Minnesota Statutes 2020, section 45.31, subdivision 3, is amended to read:

4.22 Subd. 3. **Responsibilities.** ~~A coordinator~~ An education provider is responsible for:

4.23 (1) assuring compliance with all laws and rules relating to educational offerings governed
4.24 by the commissioner;

4.25 (2) assuring that students are provided with current and accurate information relating to
4.26 the laws and rules governing their licensed activity;

4.27 (3) supervising and evaluating courses and instructors. Supervision includes assuring,
4.28 especially when a course will be taught by more than one instructor, that all areas of the
4.29 curriculum are addressed without redundancy and that continuity is present throughout the
4.30 entire course;

4.31 (4) ensuring that instructors are qualified to teach the course offering;

5.1 (5) furnishing the commissioner, upon request, with copies of course and instructor
5.2 evaluations and qualifications of instructors. Evaluations must be completed by students
5.3 and coordinators;

5.4 (6) investigating complaints related to course offerings and instructors and forwarding
5.5 a copy of the written complaints to the Department of Commerce;

5.16 offerings and providing to the students and instructor the name of the coordinator and a
5.17 telephone number at which the coordinator can be reached;

5.20 (10) providing course completion certificates within ten days of, but not before,
5.21 completion of the entire course. Course completion certificates must be completed in their
5.22 entirety. It is not necessary to provide a written course completion certificate if the course
5.23 completion certificate has been electronically delivered to the department or its designated
5.24 licensing contractor. A coordinator may require payment of the course tuition as a condition
5.25 for receiving the course completion certificate;
