### **Bill Description**

This bill is relating to agriculture, amending food handler license provisions.

This bill amends Minnesota Statutes 2022, section 28A.10, and repeals Minnesota Statutes 2022, section 34.07.

This bill clarifies fund authority established in 2023 for food handler license fees in Minnesota Statutes 2022, section 28A.08, Subd. 4, by removing reference to the state treasury and general fund in Minnesota Statutes 2022, section 28A.10.

This bill repeals the beverage inspection account in Minnesota Statutes 2022, section 34.07, aligning with the food handler license account established in 2023 in Minnesota Statutes 2022, section 28A.08, Subd. 4.

## **Assumptions**

Fund authorities specified in Minnesota Statutes 2022, sections 28A.10 and 28A.08 Subd. 4, established in 2023, are in conflict. The authority established in Minnesota Statutes 2022, section 28A.08, Subd. 4 precedes that in Minnesota Statutes 2022, section 28A.10.

Existence of both the beverage inspection account and food handler license account does not result in dual fee collection for persons specified in Minnesota Statutes 2022, section 34.02. Fees are deposited in the food handler license account in Minnesota Statutes 2022, section 28A.08; no longer in the beverage inspection account. Minnesota Statutes 2022, section 34.07 is no longer necessary. Should this pass, it is assumed that the fund balance on the beverage inspection account would transfer to the food handler license account and therefore the impact would be net zero to the fund.

Passage of this bill will clarify fund and account authority for fees collected under Minnesota Statutes 2022, section 28A.08, Subd. 3.
