1.3 Page 7, after line 26, insert:

1.4 "(g) \$50,000 in fiscal year 2017 is from the  
1.5 workforce development fund for a grant  
1.6 to the West Bank Athletic Club to provide  
1.7 programming to Somali youth.

1.8 Funds available under this paragraph may be  
1.9 used to promote healthy youth development,  
1.10 leadership skills, and self-empowerment  
1.11 through:

1.12 (1) career exploration, job skills  
1.13 development, and training;

1.14 (2) fostering youth entrepreneurship,  
1.15 community leadership, and business  
1.16 leadership skills;

1.17 (3) community service, and civic and  
1.18 community engagement opportunities  
1.19 provided in a safe and healthy environment  
1.20 that is free of drugs, violence, and exposure  
1.21 to radical ideologies, and that is provided in  
1.22 partnership with law enforcement and other  
1.23 community organizations;

1.24 (4) mentoring and tutoring for academics,  
1.25 financial literacy, and job readiness skills;

- 2.1 (5) intensive team building and leadership  
2.2 development skill building through athletic  
2.3 programming after school and during school  
2.4 breaks and holidays;
- 2.5 (6) prevention of adolescent gang  
2.6 involvement and self-destructive behavior  
2.7 through:
- 2.8 (i) radicalization awareness;
- 2.9 (ii) positive interaction with community law  
2.10 enforcement personnel; and
- 2.11 (iii) development of problem solving skills  
2.12 and conflict resolution within the spiritual  
2.13 framework of the community and cultural  
2.14 values.
- 2.15 Activities and services supported by  
2.16 funds available under this paragraph may  
2.17 be provided in collaboration with other  
2.18 organizations, including, but not limited  
2.19 to: law enforcement, state and local public  
2.20 agencies, interfaith organizations, nonprofit  
2.21 organizations, and East African community  
2.22 organizations and stakeholders.
- 2.23 (h) \$50,000 in fiscal year 2017 is from the  
2.24 workforce development fund for a grant  
2.25 to the Voice of East African Women for  
2.26 East African youth empowerment and  
2.27 anti-violence skills training and mentorship.
- 2.28 Grant funds must be used to:
- 2.29 (1) develop training and mentorship  
2.30 strategies that provide employment skills,  
2.31 job search and placement, and employment  
2.32 support activities;
- 2.33 (2) develop and implement strategies  
2.34 to reduce and eliminate the factors and

3.1 influences that make East African youth  
3.2 vulnerable to recruitment by violent  
3.3 organizations; and

3.4 (3) develop strategies, programs, and  
3.5 services, in collaboration with public  
3.6 entities and other community and private  
3.7 organizations that provide services to at-risk  
3.8 youth and families, to reduce and eliminate  
3.9 the vulnerability of East African youth  
3.10 to recruitment by violent organizations.  
3.11 Strategies, programs, and services may  
3.12 include but are not limited to:

3.13 (i) after-school and summer programs for East  
3.14 African youth that are structured and include  
3.15 components offering physical recreation,  
3.16 education enrichment, art, music, and social  
3.17 activities that are culturally appropriate;

3.18 (ii) individual and family oriented financial  
3.19 planning and management skill building;

3.20 (iii) culturally appropriate individual and  
3.21 family counseling focusing on education and  
3.22 employment counseling; and

3.23 (iv) information regarding and direct links  
3.24 to entities that provide employment skills  
3.25 training, job search and placement, and  
3.26 employment support activities and services.

3.27 Activities and services supported with funds  
3.28 available under this section may be provided  
3.29 in collaboration with other organizations,  
3.30 including but not limited to law enforcement,  
3.31 state and local public agencies, interfaith  
3.32 organizations, nonprofit organizations, and  
3.33 East African community organizations and  
3.34 stakeholders."
