1.4 Subdivision 1. **Membership.** (a) A Legislative-Citizen Commission on Minnesota  
1.5 Resources of 17 members is created in the legislative branch, consisting of the chairs  
1.6 of the house of representatives and senate committees on environment and natural  
1.7 resources finance or designees appointed for the terms of the chairs, four members of the  
1.8 senate appointed by the Subcommittee on Committees of the Committee on Rules and  
1.9 Administration, and four members of the house of representatives appointed by the speaker.

1.10 At least two members from the senate and two members from the house of  
1.11 representatives must be from the minority caucus. Members are entitled to reimbursement  
1.12 for per diem expenses plus travel expenses incurred in the services of the commission.

1.13 Seven citizens are members of the commission, five appointed by the governor, one  
1.14 appointed by the Senate Subcommittee on Committees of the Committee on Rules and  
1.15 Administration, and one appointed by the speaker of the house. The citizen members  
1.16 are selected and recommended to the appointing authorities according to subdivision  
1.17 1a and must:

1.18 (1) have experience or expertise in the science, policy, or practice of the protection,  
1.19 conservation, preservation, and enhancement of the state's air, water, land, fish, wildlife,  
1.20 and other natural resources;

1.21 (2) have strong knowledge in the state's environment and natural resource issues  
1.22 around the state; and

1.23 (3) have demonstrated ability to work in a collaborative environment.

1.24 (b) Members shall develop procedures to elect a chair that rotates between legislative  
1.25 and citizen members each meeting. A citizen member, a senate member, and a house of  
1.26 representatives member shall serve as chairs. The citizen members, senate members, and  
1.27 house of representatives members must select their respective chairs. The chair shall

2.1 preside and convene meetings as often as necessary to conduct duties prescribed by this  
2.2 chapter.

2.3 (c) Appointed legislative members shall serve on the commission for two-year  
2.4 terms, beginning in January of each odd-numbered year and continuing through the end  
2.5 of December of the next even-numbered year. Appointed citizen members shall serve  
2.6 four-year terms, beginning in January of the first year and continuing through the end  
2.7 of December of the final year. Citizen and legislative members continue to serve until  
2.8 their successors are appointed.

2.9 (d) A citizen member may be removed by an appointing authority for cause.  
2.10 Vacancies occurring on the commission shall not affect the authority of the remaining  
2.11 members of the commission to carry out their duties, and vacancies shall be filled for the  
2.12 remainder of the term in the same manner under paragraph (a).

2.25 ~~(f)~~ (e) Citizen members are entitled to per diem and reimbursement for expenses  
2.26 incurred in the services of the commission, as provided in section 15.059, subdivision 3.
