#### **Bill Description**

Sections one and two of this bill modify the Long-Term Facilities Maintenance (LTFM) statute (Minnesota Statute 123B.595). The bill allows districts with approved energy efficiency projects to levy for additional revenue when approved by the Commissioner. Districts would need to supply additional project documentation to MDE for approval. The bill removes the existing prohibition for including energy efficiency projects as a qualifying expense. The LTFM sections are effective for revenue for FY26 and later. Section 3 of the bill modifies capital grants and loan provisions under Minnesota Statutes 2023, section 126C.69 by striking the prohibition of heating system improvements from the list of qualifying uses. This provision is effective July 1, 2024.

### **Assumptions**

Under Minnesota Statutes 2023, section 123B.595, no minimum cost has been established for proposed energy efficiency projects. Currently, proposed projects may range from \$0 and beyond. Proposed bill language designates no state aid; therefore, all approved energy efficiency projects will be levied upon the local tax payer.

Energy efficiency projects have their own provisions under Minnesota Statutes 2023, section 123B.65. This statute allows a district to enter into a guaranteed energy-savings contract with a qualified provider, or a district may enter into an installment payment contract for the purchase and installation of energy conservation measures.

It is assumed that state administration of capital grants and loans would be unaffected by local heating system spending choices.

A 0.2 FTE Education Finance Specialist II will be required to review and approve additional narrative information for the proposed energy efficiency projects under the 10-year LTFM plan.

# **Local Fiscal Impact**

Districts would be allowed to levy additional revenue for energy efficiency projects. With no prior energy efficiency data to track, the increased local levy amount for energy efficiency is unknown.
