3.14 consent when the following circumstances exist or the actor reasonably believes them to
3.15 exist:

3.16 (1) when used by a public officer or one assisting a public officer under the public
3.17 officer's direction:

3.18 (i) in effecting a lawful arrest; or

3.19 (ii) in the execution of legal process; or

3.20 (iii) in enforcing an order of the court; or

3.21 (iv) in executing any other duty imposed upon the public officer by law; or

3.22 (2) when used by a person not a public officer in arresting another in the cases and in
3.23 the manner provided by law and delivering the other to an officer competent to receive the
3.24 other into custody; or

3.25 (3) when used by any person in resisting or aiding another to resist an offense against

4.24 pupil, in the exercise of lawful authority, to restrain or correct the child or pupil; or

4.25 ~~(b)~~ (2) when used by a teacher, school principal, school employee, school bus driver,
4.26 other agent of a district, or other member of the instructional, support, or supervisory staff
4.27 of a public or nonpublic school upon or toward a child when necessary to restrain the child
4.28 ~~from self-injury or injury to any other person or property~~ to prevent bodily harm or death

5.2 Sec. 9. **[626.8482] SCHOOL RESOURCE OFFICERS; DUTIES; TRAINING.**

5.3 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms have
5.4 the meanings provided.

5.5 (b) "School" means an elementary school, middle school, or secondary school, as defined
5.6 in section 120A.05, subdivisions 9, 11, and 13, or a Tribal contract or grant school eligible
5.7 for aid under section 124D.83.

5.8 (c) "School resource officer" means a peace officer who is assigned to work in an
5.9 elementary or secondary school during the regular instructional school day as one of the
5.10 officer's regular responsibilities through the terms of a contract entered between the peace
5.11 officer's employer and the designated school district or charter school.

5.12 Subd. 2. **Duties.** (a) A school resource officer's contractual duties with a school district
5.13 or charter school may include:

5.14 (1) fostering a positive school climate through relationship building and open
5.15 communication;

5.16 (2) protecting students, staff, and visitors to the school grounds from criminal activity;

5.17 (3) coordinating criminal investigations between law enforcement and school officials;

5.18 (4) providing advice on safety drills;

5.19 (5) identifying vulnerabilities in school facilities and safety protocols;

5.20 (6) educating and advising students and staff on law enforcement topics; and

5.21 (7) enforcement of criminal laws and execution of other duties imposed upon peace
5.22 officers by law.

5.23 (b) A school district or charter school may contract with a school resource officer's
5.24 employer for the officer to perform additional duties to those mandated in paragraph (a).

5.25 (c) A school resource officer may not participate in the enforcement of discipline for
5.26 violations of school rules.

5.27 (d) Nothing in the enumeration of these duties or the inclusion of them in a contract
5.28 between a school resource officer's employer and the designated school district or charter
5.29 school shall create a special duty to any individual.

6.1 Subd. 3. **Instruction required.** (a) Except as provided for in paragraphs (b) through
6.2 (d), beginning December 1, 2025, a peace officer assigned to serve as a school resource
6.3 officer must complete a training course that provides instruction on the learning objectives
6.4 identified in subdivision 4 prior to assuming the duties of a school resource officer.

6.5 (b) A peace officer who has completed either the School Safety Center standardized
6.6 Basic School Resource Officer Training or the National School Resource Officer Basic
6.7 School Resource Officer course prior to June 1, 2025, shall be deemed to be in compliance
6.8 with the training mandated under paragraph (a).

6.9 (c) If an officer's employer is unable to provide the required training course to the officer
6.10 prior to the officer assuming the duties of a school resource officer, the officer must complete
6.11 the required training within six months of assuming the duties of a school resource officer.

6.12 (d) An officer who is serving as a substitute school resource officer for fewer than 60
6.13 school days, is not obligated to complete the required training.

6.14 (e) For each school resource officer employed by an agency, the chief law enforcement
6.15 officer must maintain a copy of the most recent training certificate issued to the officer for
6.16 completion of the training mandated under this section.

6.17 Subd. 4. **Training course.** (a) By January 15, 2025, the Department of Public Safety
6.18 School Safety Center, in consultation with the board, shall prepare learning objectives for
6.19 training courses to instruct peace officers in serving as a school resource officer. At a
6.20 minimum, the learning objectives must ensure officers receive training on:

6.21 (1) the juvenile justice system;

6.22 (2) legal standards for peace officers to use force to detain or arrest students in schools;

6.23 (3) legal standards for school employees and contractors to use force to detain, discipline,
6.24 and arrest students in school;

6.25 (4) de-escalation techniques and physical intervention strategies for handling conflicts
6.26 in schools;

6.27 (5) responding to persons experiencing a mental health crisis, with an emphasis placed
6.28 on juveniles;

6.29 (6) understanding and working with students with disabilities and students receiving
6.30 special education services;

6.31 (7) juvenile brain development, including limitations on impulse control;

6.32 (8) the impact of childhood trauma on juvenile behavior;

7.1 (9) responding to threats of violence against students and schools;

7.2 (10) detecting juvenile exploitation;

7.3 (11) investigating crimes committed in schools, including student and parental rights;

7.4 (12) identifying vulnerabilities in school facilities and safety protocols; and

7.5 (13) mandated safety drills and best practices in conducting safety drills.

7.6 (b) The Department of Public Safety School Safety Center may also approve supplemental
 7.7 training courses that are offered by providers who have trained school resource officers in
 7.8 the state prior to development of the learning objectives required under paragraph (a). At a
 7.9 minimum, an approved supplemental course must provide instruction on each of the board's
 7.10 learning objectives that were not covered in the provider's existing school resource officer
 7.11 course curriculum.

7.13 Sec. 10. **DEPARTMENT OF PUBLIC SAFETY; APPROPRIATION.**

7.14 \$150,000 in fiscal year 2024 and \$490,000 in fiscal year 2025 are appropriated from the
 7.15 general fund to the commissioner of public safety to increase staffing in the department's
 7.16 school safety center and perform the duties required by this act. The general fund base for
 7.17 this appropriation is \$490,000 in fiscal year 2026 and fiscal year 2027.

7.18 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.19 Sec. 11. **SCHOOL RESOURCE OFFICER TRAINING REIMBURSEMENT;**
 7.20 **APPROPRIATION.**

7.21 \$250,000 in fiscal year 2025 is appropriated from the general fund to the commissioner
 7.22 of public safety to reimburse law enforcement agencies for costs associated with school
 7.23 resource officer training, backfilling staffing costs, and lodging while a school resource
 7.24 officer is attending mandatory training."
