1.2 Page 15, after line 16, insert:

1.3 "Sec. 14. [148.9986] EXCHANGING INFORMATION.

1.4 The board shall report to the Office of Complementary and Alternative Health  
1.5 Practices all revocations or suspensions of registered massage and bodywork therapists.  
1.6 Upon request by the Office of Complementary and Alternative Health Practices, the board  
1.7 may share all complaint, investigatory, and disciplinary data relating to a previously or  
1.8 currently registered massage and bodywork therapist."

1.9 Page 15, after line 20, insert:

1.10 "Section 1. Minnesota Statutes 2014, section 146A.06, subdivision 3, is amended to  
1.11 read:

1.12 Subd. 3. **Exchanging information.** (a) The office shall establish internal operating  
1.13 procedures for:

1.14 (1) exchanging information with state boards; agencies, including the Office of  
1.15 Ombudsman for Mental Health and Developmental Disabilities; health-related and law  
1.16 enforcement facilities; departments responsible for licensing health-related occupations,  
1.17 facilities, and programs; and law enforcement personnel in this and other states; and

1.18 (2) coordinating investigations involving matters within the jurisdiction of more  
1.19 than one regulatory agency.

1.20 (b) The procedures for exchanging information must provide for the forwarding to  
1.21 the entities described in paragraph (a), clause (1), of information and evidence, including  
1.22 the results of investigations, that are relevant to matters within the regulatory jurisdiction  
1.23 of the organizations in paragraph (a). The data have the same classification in the hands of  
1.24 the agency receiving the data as they have in the hands of the agency providing the data.

2.1 (c) The office shall establish procedures for exchanging information with other  
2.2 states regarding disciplinary action against unlicensed complementary and alternative  
2.3 health care practitioners.

2.4 (d) The office shall forward to another governmental agency any complaints received  
2.5 by the office that do not relate to the office's jurisdiction but that relate to matters within  
2.6 the jurisdiction of the other governmental agency. The agency to which a complaint is  
2.7 forwarded shall advise the office of the disposition of the complaint. A complaint or  
2.8 other information received by another governmental agency relating to a statute or rule  
2.9 that the office is empowered to enforce must be forwarded to the office to be processed  
2.10 in accordance with this section.

2.11 (e) The office shall furnish to a person who made a complaint a description of the  
2.12 actions of the office relating to the complaint.

2.13 (f) The office shall report to the Board of Nursing all final disciplinary actions  
2.14 against individuals practicing massage and bodywork as unlicensed complementary and  
2.15 alternative health practitioners. Upon request by the Board of Nursing, the office may  
2.16 share all complaint, investigatory, and disciplinary data regarding a named individual who  
2.17 has practiced or is practicing massage and bodywork as an unlicensed complementary and  
2.18 complementary and alternative health practitioner.

2.19 Sec. 2. Minnesota Statutes 2014, section 146A.09, is amended by adding a subdivision  
2.20 to read:

2.21 Subd. 8. **Registered massage and bodywork therapists.** No person whose  
2.22 registration as a massage and bodywork therapist under sections 148.981 to 148.9883  
2.23 has been suspended or revoked by the Board of Nursing may practice as an unlicensed  
2.24 complementary and alternative health care practitioner under Minnesota Statutes, chapter  
2.25 146A, during a period of suspension or revocation."
