Bill Description

HF 1371-0 amends M.S. § 144.551, subd. 1 as follows:

Section 1, subd. 1 (26) amends M.S. § 144.551, subd. 1, to add to the list of new hospital bed moratorium exclusions a project involving the addition of 21 new beds in an existing psychiatric hospital in Hennepin County that is exclusively for patients under 21 years of age on the date of admission.

Assumptions

Because no further public interest review would be required for this project and ongoing monitoring of the additional beds would be infinitesimal to existing day-to-day activity, the Department assumes no fiscal impact because of this amendment.
