1.5 Section 1. Minnesota Statutes 2014, section 123B.09, subdivision 1, is amended to read:

1.6 Subdivision 1. **School board membership.** The care, management, and control of
1.7 independent districts is vested in a board of directors, to be known as the school board.
1.8 The term of office of a member shall be four years commencing on the first Monday in
1.9 January and until a successor qualifies. The membership of the board shall consist of six
1.10 elected directors together with such ex officio member as may be provided by law. The
1.11 board may submit to the electors at any school election the question whether the board
1.12 shall consist of seven members. If a majority of those voting on the proposition favor a
1.13 seven-member board, a seventh member shall be elected at the next election of directors
1.14 for a four-year term and thereafter the board shall consist of seven members.

1.15 Those districts with a seven-member board may submit to the electors at any school
1.16 election at least 150 days before the next election of three members of the board the

2.22 general election described in paragraph (a) or a political party that presents candidates at
2.23 an election as required by paragraph (b) becomes a major political party as of January
2.24 1 following that election and retains its major party status for at least two state general
2.25 elections even if the party fails to present a candidate who receives the number and
2.26 percentage of votes required under paragraph (a) or fails to present candidates as required

3.2 the most recent state general election a certification that the party has met the foregoing
3.3 requirements, and met the requirements of paragraph (b) or (e), as applicable.

3.4 (b) To be considered a minor party in all elections statewide, the political party must
3.5 have presented at least one candidate for election to the office of:

3.6 (1) governor and lieutenant governor, secretary of state, state auditor, or attorney
3.7 general, at the last preceding state general election for those offices; or

3.8 (2) presidential elector or U.S. senator at the preceding state general election for
3.9 presidential electors; and

3.10 (3) who received votes in each county that in the aggregate equal at least one percent

3.26 (e) A minor party that qualifies to be a major party loses its status as a minor party
3.27 at the time it becomes a major party. Votes received by the candidates of a major party
3.28 must be counted in determining whether the party received sufficient votes to qualify as a
3.29 minor party, notwithstanding that the party does not receive sufficient votes to retain its
3.30 major party status. To be considered a minor party in an election in a legislative district,
3.31 the political party must have presented at least one candidate for a legislative office in that
3.32 district who received votes from at least ten percent of the total number of individuals
3.33 who voted for that office, or its members must have presented to the secretary of state a
3.34 nominating petition in a form prescribed by the secretary of state containing the valid
3.35 signatures of party members in a number equal to at least ten percent of the total number of

4.12 Subdivision 1. **Form.** Both paper and electronic voter registration applications must
4.13 contain the same information unless otherwise provided by law. A voter registration
4.14 application must contain spaces for the following required information: voter's first name,
4.15 middle name, and last name; voter's previous name, if any; voter's current address; voter's
4.16 previous address, if any; voter's date of birth; voter's municipality and county of residence;
4.17 voter's telephone number, if provided by the voter; date of registration; current and valid
4.18 Minnesota driver's license number or Minnesota state identification number, or if the voter

4.33 (6) have not been found by a court to be legally incompetent to vote;

5.1 (7) have the right to vote because, if I have been convicted of a felony, my felony
5.2 sentence has expired (been completed) or I have been discharged from my sentence; and

5.3 (8) have read and understand the following statement: that giving false information
5.4 is a felony punishable by not more than five years imprisonment or a fine of not more
5.5 than \$10,000, or both."

5.6 The certification must include boxes for the voter to respond to the following
5.7 questions:

5.8 "(1) Are you a citizen of the United States?" and

5.9 "(2) Will you be 18 years old on or before election day?"

5.10 And the instruction:

5.11 "If you checked 'no' to either of these questions, do not complete this form."

5.12 ~~A paper voter registration application must be of suitable size and weight for~~
5.13 ~~mailing.~~ The form of the voter registration application and the certification of voter
5.14 eligibility must be as provided in this subdivision and approved by the secretary of state.
5.15 Voter registration forms authorized by the National Voter Registration Act must also be
5.16 accepted as valid. The federal postcard application form must also be accepted as valid if
5.17 it is not deficient and the voter is eligible to register in Minnesota.

5.18 An individual may use a voter registration application to apply to register to vote in
5.19 Minnesota or to change information on an existing registration.

5.24 secretary of state. The secretary of state must determine whether the data newly indicates
5.25 that any individuals who have active records in the statewide voter registration system

6.3 (a) A law enforcement agency that is notified by affidavit of an alleged violation of
6.4 this chapter shall promptly investigate. Upon receiving an affidavit alleging a violation
6.5 of this chapter, a county attorney shall promptly forward it to a law enforcement agency
6.6 with jurisdiction for investigation. If there is probable cause for instituting a prosecution,
6.7 the county attorney shall proceed by complaint or present the charge, with whatever
6.8 evidence has been found, to the grand jury according to the generally applicable standards

6.28 for absentee ballots is accepted pursuant to section 203B.04. The county auditor or
6.29 municipal clerk shall provide first class postage for the return envelope. The directions
6.30 for casting an absentee ballot shall be printed in at least 14-point bold type with heavy
6.31 leading and may be printed on the ballot envelope. When a person requests the directions

7.8 may be mailed as provided in the directions for casting the absentee ballots or may be
7.9 left with the county auditor or municipal clerk who transmitted the absentee ballots to the

10.10 candidate's request in accordance with paragraph (c), the candidate's campaign contact
10.11 address. The form for the affidavit of candidacy must allow the candidate to request, if
10.12 eligible, that the candidate's address of residence be classified as private data, and to
10.13 provide the certification required under paragraph (c) for classification of that address.

10.14 (b) For an office whose residency requirement must be satisfied by the close of the

11.5 accordance with section 204D.03, subdivision 3, or 204D.10, subdivision 1:

11.6 (1) dies;

11.7 (2) ~~withdraws as provided in section 204B.12, subdivision 1; or~~

11.8 (3) withdraws by filing an affidavit of withdrawal, as provided in paragraph (b),
11.9 at least one day prior to the general election with the same official who received the

32.31 Subd. 2. **Petitions for presidential electors and alternates.** This subdivision
 32.32 does not apply to candidates for presidential elector or alternate nominated by major
 32.33 political parties. Major party candidates for presidential elector or alternate are certified
 32.34 under section 208.03. Other presidential electors or alternates are nominated by petition

33.1 pursuant to this section. On petitions nominating presidential electors or alternates, the
 33.2 names of the candidates for president and vice-president shall be added to the political
 33.3 party or political principle stated on the petition. One petition may be filed to nominate a

34.17 (e) "Unaffiliated presidential candidate" means a candidate for president who

34.20 (f) "Vice president" means the vice president of the United States.

34.21 Sec. 7. **[208.42] DESIGNATION OF STATE'S ELECTORS.**

34.22 (a) For each elector position in this state, a political party contesting the position, or
34.23 an unaffiliated presidential candidate, shall submit to the secretary of state the names of
34.24 two qualified individuals. One of the individuals must be designated "elector nominee"
34.25 and the other "alternate elector nominee."

34.26 (b) Except as otherwise provided in sections 208.44 to 208.47, this state's electors
34.27 are the winning elector nominees under the laws of this state.

34.29 Each elector nominee and alternate elector nominee of a political party shall execute
34.30 the following pledge: "If selected for the position of elector, I agree to serve and to mark

34.32 that nominated me." Each elector nominee and alternate elector nominee of an unaffiliated

36.9 (a) At the time designated for elector voting in section 208.06, and after all vacant

36.12 elector's presidential and vice-presidential ballots with the elector's votes for the offices

36.22 (c) An elector who refuses to present a ballot, presents an unmarked ballot, or
36.23 presents a ballot marked in violation of the elector's pledge executed under section 208.43
36.24 or 208.45, paragraph (c), vacates the office of elector, creating a vacant position to be
36.25 filled under section 208.45.

36.26 (d) The secretary of state shall distribute ballots to and collect ballots from a
36.27 substitute elector and repeat the process under this section of examining ballots, declaring
36.28 and filling vacant positions as required, and recording appropriately completed ballots from
36.29 the substituted electors, until all of this state's electoral votes have been cast and recorded.

36.30 **Sec. 12. [208.47] ELECTOR REPLACEMENT; ASSOCIATED CERTIFICATES.**

36.31 (a) After the vote of this state's electors is completed, if the final list of electors
36.32 differs from any list that the governor previously included on a certificate of ascertainment
36.33 prepared and transmitted under United States Code, title 3, section 6, the secretary of state

37.1 immediately shall prepare an amended certificate of ascertainment and transmit it to
37.2 the governor for the governor's signature.

37.3 (b) The governor immediately shall deliver the signed amended certificate of
37.4 ascertainment to the secretary of state and a signed duplicate original of the amended
37.5 certificate of ascertainment to all individuals entitled to receive this state's certificate of
37.6 ascertainment, indicating that the amended certificate of ascertainment is to be substituted

37.12 Sec. 13. **[208.48] UNIFORMITY OF APPLICATION AND CONSTRUCTION.**

37.13 In applying and construing sections 208.40 to 208.48, consideration must be given
37.14 to the need to promote uniformity of the law with respect to their subject matter among
37.15 states that enact the Uniform Faithful Presidential Electors Act or similar law.

37.16 Sec. 14. Minnesota Statutes 2014, section 209.01, subdivision 2, is amended to read:

37.17 Subd. 2. **Statewide office.** For purposes of this chapter, "statewide office" means the
37.18 office of governor, lieutenant governor, attorney general, state auditor, secretary of state,
37.19 chief justice or associate justice of the Supreme Court, judge of the Court of Appeals,
37.20 United States senator, or presidential elector or alternate.
