1.5 person to drive, operate, or be in physical control of any motor vehicle, as defined in section
1.6 169A.03, subdivision 15, except for motorboats in operation and off-road recreational
1.7 vehicles, within this state or on any boundary water of this state when:

1.8 (1) the person is under the influence of alcohol;

1.9 (2) the person is under the influence of a controlled substance;

1.10 (3) the person is under the influence of an intoxicating substance and the person knows
1.11 or has reason to know that the substance has the capacity to cause impairment;

1.12 (4) the person is under the influence of a combination of any two or more of the elements
1.13 named in clauses (1) to (3);

1.14 (5) the person's alcohol concentration at the time, or as measured within two hours of
1.15 the time, of driving, operating, or being in physical control of the motor vehicle is 0.08 or
1.16 more;

1.17 (6) the vehicle is a commercial motor vehicle or a light rail transit vehicle and the person's
1.18 alcohol concentration at the time, or as measured within two hours of the time, of driving,
1.19 operating, or being in physical control of the commercial motor vehicle is 0.04 or more; or

1.20 (7) the person's body contains any amount of a controlled substance listed in Schedule

2.2 Subd. 2. **Reporting test failure.** (a) If a person submits to a test, the results of that test
2.3 must be reported to the commissioner and to the authority having responsibility for
2.4 prosecution of impaired driving offenses for the jurisdiction in which the acts occurred, if
2.5 the test results indicate:

2.6 (1) an alcohol concentration of 0.08 or more;

2.7 (2) an alcohol concentration of 0.04 or more, if the person was driving, operating, or in
2.8 physical control of a commercial motor vehicle or a light rail transit vehicle at the time of
2.9 the violation; or

2.10 (3) the presence of a controlled substance listed in Schedule I or II or its metabolite,
2.11 other than marijuana or tetrahydrocannabinols.

2.12 (b) If a person submits to a test and the test results indicate the presence of an intoxicating
2.13 substance, the results of that test must be reported to the authority having responsibility for
2.14 prosecution of impaired driving offenses for the jurisdiction in which the acts occurred.

2.18 Subd. 4. **Test failure; license revocation.** (a) Upon certification by the peace officer
2.19 that there existed probable cause to believe the person had been driving, operating, or in
2.20 physical control of a motor vehicle in violation of section 169A.20 (driving while impaired)
2.21 and that the person submitted to a test and the test results indicate an alcohol concentration
2.22 of 0.08 or more or the presence of a controlled substance listed in Schedule I or II or its
2.23 metabolite, other than marijuana or tetrahydrocannabinols, then the commissioner shall
2.24 revoke the person's license or permit to drive, or nonresident operating privilege:

2.25 (1) for a period of 90 days, or, if the test results indicate an alcohol concentration of
2.26 twice the legal limit or more, not less than one year;

2.27 (2) if the person is under the age of 21 years, for a period of not less than 180 days or,
2.28 if the test results indicate an alcohol concentration of twice the legal limit or more, not less

3.29 alleged offense occurred. The hearing is to the court and may be conducted at the same time
3.30 and in the same manner as hearings upon pretrial motions in the criminal prosecution under
3.31 section 169A.20 (driving while impaired), if any. The hearing must be recorded. The
3.32 commissioner shall appear and be represented by the attorney general or through the
3.33 prosecuting authority for the jurisdiction involved. The hearing must be held at the earliest

5.29 626.13 to 626.17 shall certify to the commissioner of public safety:

5.30 (1) when a person refuses to comply with the execution of the search warrant; or

5.31 (2) if a person submits to the test and the test results indicate:

- 6.1 (i) an alcohol concentration of 0.08 or more;
- 6.2 (ii) an alcohol concentration of 0.04 or more, if the person was driving, operating, or in

6.13 vehicle in violation of section 169A.20, and that the person submitted to a test and the test
6.14 results indicate an alcohol concentration of 0.08 or more or the presence of a controlled
6.15 substance listed in Schedule I or II or its metabolite, other than marijuana or
6.16 tetrahydrocannabinols, the commissioner shall revoke the person's license or permit to drive
6.17 or nonresident operating privilege:

7.24 (b) On behalf of the commissioner, a peace officer requiring a test or directing the
7.25 administration of a chemical test of a person driving, operating, or in physical control of a
