Dear Members of the Legislature,

I am reaching out to share my support for HF 3371/SF 2992, Keystone Community Services' request of \$4 million to establish a new community food site in Ramsey County.

The effects of the pandemic have not subsided and the demand for food resources continues to increase month after month. Before the pandemic, 1 in 11 Minnesotans were experiencing hunger; that number increased to 1 in 9 in 2020. However, our society is not experiencing a food shortage, we have an abundance of food. But to address food insecurity and feed all Minnesotans, we must invest in the organizations that distribute these food resources.

Keystone operates two food shelves in St. Paul that no longer have the space or capacity to serve the East Metro. This new community food site will bring food resources throughout Ramsey County to 50,000 people a year in a dignified manner. Once funding is provided, Keystone will be able to start construction in September and open their new site in Spring 2023.

Keystone has been a steadfast partner with Ramsey County throughout COVID-19. Keystone has responded to the call from to their community by innovating and meeting residents where they are. Keystone hosted over 20 drive through distribution events in 2020 and continued these events into 2021. Keystone also expanded their foodmobile services to deliver healthy and fresh food throughout the community at residences throughout Ramsey County. I believe this to be a great use of taxpayer dollars, as hunger needs continue to grow during this pandemic.




