#### <u>Human Services Background Study Task Force</u>

- Approx. 12-month process that analyzed Minnesota licensing laws.
- Diverse group from judges, prosecutors, legislators, law enforcement, impacted individuals, lawyers, and government.
- We brought in guest speakers with expertise on the juvenile brain, addiction, the law, and several individuals who were disqualified to tell their story.
- Resulted in Legislative Report that addressed the process, data and resulting recommendations.

#### Overview of Some Issues/Conclusions

- Protecting vulnerable individuals is paramount and important mission of State of Minnesota.
- The law's purpose is to protect vulnerable individual; not a punitive law.
- The current law is more restrictive than required to protect vulnerable individuals.
- Minnesota has a unique background study process. It disqualifies more individuals, for more reasons, for longer periods of time than any other state we reviewed.
- Disqualifications impact more individuals than just those providing direct care to vulnerable. The law includes those who work in nursing home kitchens, laundry, cleaning, etc.
- Minnesota's BGS law is vastly different from federal law. I.E., Adam Walsh Act 5 year and permanent Disqualification.
- Racial Disparities. Not everyone is impacted the same by these laws. Professor Kammer will discuss this in more detail.
- Inconsistent with Minnesota's expungement laws. Waiting period for a misdemeanor is 2 years in expungement statute, but 7 years in BGS law.

#### Areas For Change

<u>Drug Offenses</u>: In MN, most drug offenses (even possession level) are felonies and have 15-year disqualification period.

- Under current law, a person is disqualified for 15 years from the date they were released from court supervision.
- So, if we have a person that commits a drug related felony in 2010, is convicted in 2011, receives 5-year probation until 2016, their disqualification ends in 2031. So, again, commits offense in 2010 DQ expires in 2031.


<u>Juvenile Records</u>: In Minnesota, juvenile records are not criminal records.

- (Not talking about those charged as adults).
- Although many of these cases are not "public data," reviewing agency must use this data when making decisions about disqualification.
- Under current law, one applies the same disqualification period for a juvenile case as an adult case. So, sticking with the drug, a felony level drug cases that occurs when 15 years old, will continue to disqualify for 15 years.

#### Two-Prong Approach


- The changes identified by the BGS Task Force may be best addressed in two or more changes.
- For example, the Task Force recommended removing non-conviction cases from BGS statute. Currently, can be disqualified based on nonconviction.
- Some cases are permanent disqualification without a chance for review.

# Total Background Studies and Disqualifications (2018 and 2019)




Distinct count of *persons* with at least one **eligible** determination by race/ethnicity (2018 and 2019 Grand Total)
