1.6 subprogram that is ~~recovery-focused~~ culturally responsive and culturally specific when the
1.7 program attests that it:

1.8 (1) improves service quality to and outcomes of a specific ~~population~~ community that
1.9 shares a common language, racial, ethnic, or social background by advancing health equity
1.10 to help eliminate health disparities; ~~and~~

1.11 (2) ensures effective, equitable, comprehensive, and respectful quality care services that

2.17 245G.17, or applicable tribal license;

2.18 (2) comprehensive assessments provided according to sections 245.4863, paragraph (a),
2.19 and 245G.05;

2.20 (3) care coordination services provided according to section 245G.07, subdivision 1,
2.21 paragraph (a), clause (5);

2.22 (4) peer recovery support services provided according to section 245G.07, subdivision
2.23 2, clause (8);

2.24 (5) on July 1, 2019, or upon federal approval, whichever is later, withdrawal management
2.25 services provided according to chapter 245F;

2.26 (6) medication-assisted therapy services that are licensed according to sections 245G.01
2.27 to 245G.17 and 245G.22, or applicable tribal license;

 5.2 that provides arrangements for off-site child care must maintain current documentation at
 5.3 the chemical dependency facility of the child care provider's current licensure to provide
 5.4 child care services. Programs that provide child care according to paragraph (c), clause (1),
 5.5 must be deemed in compliance with the licensing requirements in section 245G.19.

5.6 (e) Adolescent residential programs that meet the requirements of Minnesota Rules,
 5.7 parts 2960.0430 to 2960.0490 and 2960.0580 to 2960.0690, are exempt from the requirements
 5.8 in paragraph (c), clause (4), items (i) to (iv).

5.9 (f) Subject to federal approval, chemical dependency services that are otherwise covered
 5.10 as direct face-to-face services may be provided via two-way interactive video. The use of
 5.11 two-way interactive video must be medically appropriate to the condition and needs of the
 5.12 person being served. Reimbursement shall be at the same rates and under the same conditions
 5.13 that would otherwise apply to direct face-to-face services. The interactive video equipment
 5.14 and connection must comply with Medicare standards in effect at the time the service is
 5.15 provided.

5.16 (g) For the purpose of reimbursement under this section, substance use disorder treatment
 5.17 services provided in a group setting without a group participant maximum or maximum
 5.18 client to staff ratio under chapter 245G shall not exceed a client to staff ratio of 48 to one.
