1.2	per-child scholarship amounts based on family income. The minimum per-child scholarship
1.3	amount allowed under this section is \$25 per month.

1.5	scholarship payments to an eligible program selected by a scholarship recipient's family.
1.6	The payment system must:
1.7	(1) ensure that a program receives payment for any services in accordance with a written

1.26	scholarship account is established in the special revenue fund. Funds appropriated for great
1.27	start affordability scholarships under this section must be transferred to the account in the
1.28	special revenue fund.

1.30	affordability scholarships under this section. Any returned funds are available to be regranted.
