2.6 (2) have income equal to or less than ~~185~~ 225 percent of federal poverty level income
2.7 in the current calendar year, or be able to document their child's current participation in the
2.8 free and reduced-price lunch program or Child and Adult Care Food Program, National
2.9 School Lunch Act, United States Code, title 42, sections 1751 and 1766; the Food
2.10 Distribution Program on Indian Reservations, Food and Nutrition Act, United States Code,
2.11 title 7, sections 2011-2036; Head Start under the federal Improving Head Start for School
2.12 Readiness Act of 2007; Minnesota family investment program under chapter 256J; child

3.10 study for a high school equivalency test;

3.11 (2) are in foster care or otherwise in need of protection or services; or

3.12 (3) have experienced homelessness in the last 24 months, as defined under the federal
3.13 McKinney-Vento Homeless Assistance Act, United States Code, title 42, section 11434a.

4.5 (d) A scholarship is awarded for a 12-month period. If the scholarship recipient has not
4.6 been accepted and subsequently enrolled in a rated program within ten months of the

4.8 to be eligible for another scholarship. A child may not be awarded more than one scholarship
