Money must remain in the account for the useful life of the capital project, as determined by the grant agreement with the granting state agency, unless use of the fund is approved in writing by the granting state agency for major rehabilitation, expansion, replacement, or preservation of the capital project funded with state money, or to address a capital project for a different capital asset owned by the grantee.
 - (b) A grantee must adopt a capital project replacement policy that specifies the following for the capital project replacement fund:
- (1) the risks to be mitigated or managed by the fund;
