- 68.16 Subd. 9. **Employed persons with disabilities.** (a) Medical assistance may be paid for
- 68.17 a person who is employed and who:
- 68.18 (1) but for excess earnings or assets, meets the definition of disabled under the
- 68.19 Supplemental Security Income program;
- 68.20 (2) meets the asset limits in paragraph (d); and
- 68.21 (3) pays a premium and other obligations under paragraph (e).
- 68.22 (b) For purposes of eligibility, there is a \$65 earned income disregard. To be eligible
- 68.23 for medical assistance under this subdivision, a person must have more than \$65 of earned
- 68.24 income, be receiving an unemployment insurance benefit under chapter 268 that the person
- 68.25 began receiving while eligible under this subdivision, or be receiving family and medical
- 68.26 leave benefits under chapter 268B that the person began receiving while eligible under this

4.29 Subd. 18. **Personal care assistance choice option; generally.** (a) The commissioner
4.30 may allow a recipient of personal care assistance services to use a fiscal intermediary to
4.31 assist the recipient in paying and accounting for medically necessary covered personal care
5.1 assistance services. Unless otherwise provided in this section, all other statutory and
5.2 regulatory provisions relating to personal care assistance services apply to a recipient using
5.3 the personal care assistance choice option.

5.4 (b) Personal care assistance choice is an option of the personal care assistance program
5.5 that allows the recipient who receives personal care assistance services to be responsible

5.14 insurance, and is responsible for providing the consumer training and support in managing
5.15 the recipient's personal care assistance services.

5.17 Subd. 13. **Budget model.** (a) Under the budget model participants exercise responsibility
5.18 and control over the services and supports described and budgeted within the CFSS service
5.19 delivery plan. Participants must use services specified in subdivision 13a provided by an
5.20 FMS provider. Under this model, participants may use their approved service budget
5.21 allocation to:
