Veterans; license plates, dealer licenses and records, USDOT numbers and driver's license applications various policy changes.

Assumptions

Assume there is no fiscal impact to Department of Public Safety Driver and Vehicle Services (DVS).

Assume DVS issues special emblem plates to Disabled American Veterans organization members and this is a change in language only.

Assume it is already practice for DVS to not charge the \$100 personalization plate fee for personalized Gold Star plates.

Assume DVS cannot issue USDOT numbers and deleting the language has no fiscal impact.

Assume changing the temporary dealer license from 120 to 180 days and removing the qualified driver requirement from special registration plates is minimal and can be absorbed under the current maintenance and support contract with FAST enterprises, at no additional cost to DVS.

Assume deleting qualified driver language in Minnesota Statutes section 169A.60, subdivision 13 has no fiscal impact as DVS currently does not record or use this information.

Assume the programming required to add caretaker information option to credential applications is minimal and can be absorbed under the current maintenance and support contract with FAST enterprises, at no additional cost to DVS.

Assume remote applications for incarcerated individuals is an extension of the existing remote applications option and adding an additional category of individuals eligible to renew by mail has no fiscal impact. Assume these individuals would have renewed anyway and their remote renewal will not generate additional revenue.

Assume adding additional documents acceptable to prove residency for obtaining a REAL ID requires minimal programming and can be absorbed under the current maintenance and support contract with FAST enterprises, at no additional cost to DVS.
