Mister Chair and Committee Members:

My name is Cyndi Cunningham. I have been a Licensed Family Childcare Provider in St. Paul for 26 years and am the current Public Policy Chairperson for Lead & Care (rebranded Minnesota Childcare Provider Information Network, MCCPIN), a 501c3 sitewide association for Licensed Family Childcare Providers.

I am testifying on behalf of licensed family child care providers and **continuing to** call into question the impact of this bill on the child care industry and the quality care our children deserve.

The lobbyist working on this bill and I had exchanges of information and a meeting to attempt to reach some agreement on this bill.

We did not reach agreement as the basis that we believe this bill continues to be flawed.

The delete all amendment changes the wording to 'meet their intent' of those moving this forward to be able to access levy money for pre-school age special ed children in school-based care.

The unintended consequences are clearer with the original language, the effect is still the same: *expansion of community education school-based programing to include preschool children*.

The need for **quality care** has been repeatedly presented by this committee, these programs do not and cannot be evaluated on a quality-of-care system.

These programs have little to no standard of training for staff or a level of care expectation. I asked and was told that they may or may not be Certified Centers. So, the standard is potentially even less regulated than Certified Centers. 245H

This expansion will do little to provide safe & quality care to our littlest and most vulnerable.

FCCs are the affordable care setting. We are also the best fit for cultural connection and most critically, continuity of care. Whan a child is dropped off in my program I am the greeter and at the end of the day the care provider who turns their child back to the parent with the report of the day.
