1.4 Subd. 2. **Monitoring required.** (a) When the court sentences a person described in
1.5 subdivision 1 for a violation of section 169A.20, subdivision 1, clause (1), (5), or (6), or 2,
1.6 clause (1), to a stayed sentence and when electronic monitoring equipment is available to
1.7 the court, the court shall require that the person participate in a program of electronic alcohol
1.8 monitoring in addition to any other conditions of probation or jail time it imposes. The court
1.9 must order the monitoring for a minimum of 30 consecutive days during each year of the
1.10 person's probationary period.

1.11 (b) When the court sentences a person described in subdivision 1 for a violation of
1.12 section 169A.20, subdivision 1, clause (1), (5), or (6), or 2, clause (1), to a stayed sentence
1.13 and when electronic alcohol-monitoring equipment is not available to the court, the court

2.5 (b) Unless maximum bail is imposed under section 629.471, a person described in
2.6 paragraph (a) may be released from detention only if the person agrees to the following

2.29 Subd. 2. **Felony violations.** (a) A person charged with violating section 169A.20 within
2.30 ten years of the first of three or more qualified prior impaired driving incidents may be
2.31 released from detention only if the following conditions are imposed:

- 3.1 (1) the conditions described in subdivision 1, paragraph (b), if applicable;
- 3.2 (2) the impoundment of the registration plates of the vehicle used to commit the violation,
3.3 unless already impounded;
- 3.4 (3) if the vehicle used to commit the violation was an off-road recreational vehicle or a
3.5 motorboat, the impoundment of the off-road recreational vehicle or motorboat;
- 3.6 (4) a requirement that the person report weekly to a probation agent;
- 3.7 (5) a requirement that the person abstain from consumption of alcohol and intoxicating
3.8 substances and controlled substances other than use in accordance with a valid prescription
3.9 and submit to random alcohol tests or urine analyses at least weekly a program to monitor
3.10 that abstinence;
- 3.11 (6) a requirement that, if convicted, the person reimburse the court or county for the
3.12 total cost of these services; and
- 3.13 (7) any other conditions of release ordered by the court.
