The City of Saint Paul's Business Review Council (BRC) writes to provide our support for the proposed legislation HF4461 to require a license to sell copper wire.

The BRC recognizes the widespread issue of copper wire theft impacting various cities and towns in Minnesota. The BRC also acknowledges the specific challenges this problem poses for the City of Saint Paul. In 2023, Saint Paul's staff allocated an extra \$1 million to improve staff and resources for repairing and replacing streetlights and signals damaged by wire theft. Unfortunately, the newly installed copper wire was stolen within hours. The City's operational infrastructure, such as streetlights and traffic signals, must be protected because it is crucial for public safety and quality of life in all Minnesota communities. It is imperative to incorporate HF4461 into legislation to uphold our commitment to our citizens.

Therefore, during the monthly Business Review meeting of April 3, 2024, our Council unanimously passed this motion:

"...That the Business Review Council support the proposed legislation in HF4461 to require a license to sell copper wire to prevent and deter copper wire theft."

While our cities and partners continue to work as quickly as possible to replace and repair damaged streetlights, the lack of a long-term, sustainable solution comes at a great cost to our municipalities and residents.

Thank you for the opportunity to testify in support of HF4461 with amendments. I am the Director of Membership and Government Affairs for the Electrical Association, an association of 265 electrical contractors around the state, performing electrical installations in your community. The Electrical Association provides support to these small businesses through government advocacy, continuing education, workforce strategies, and apprenticeship education.

First, I want to thank Representative Hollins and the City of St. Paul for thoughtfully addressing our concerns regarding the initial bill language. Allowing electricians to use their existing license instead of requiring yet another license is very much appreciated. Electricians remove outdated wiring as part of their regular work and these precious metals should be recaptured and recycled, not placed in a dumpster to be hauled to a landfill.

Copper theft is real and expensive. Street lights, EV Charging stations, the money thieves receive for the copper they steal is tiny in comparison to the repairs needed to fix their crimes. In rural Minnesota a particular type of installation that I prefer not to reveal so as to not give thieves ideas, might yield \$6,000-\$7,000 in copper at a scrap yard, but costs \$30,000-\$50,000 to repair. A member fixed one of these installations, only to be called back after the following weekend to fix it again because the thieves struck twice. Security needed to be put in place to prevent future thefts. Please contact me directly if you'd like to learn more. Over the past week I've heard stories of this occurring in St. Cloud, Mankato, and New Ulm.

We'd like to be a part of making these copper thefts more difficult so the good work electrical contractors perform stays in place. By allowing existing licensing as credentials to sell copper, it makes certain people with a business reason can sell copper while making it more difficult for those that cannot provide proper justification to get paid for stolen copper.

Increase in Copper Wire Theft – **Not Just Street Lights**

City of Saint Paul leaders to champion proposed new state legislation co-authored by Senator Pappas and Representative Hollins to curb the selling of stolen copper metals



In recent years, the City of Saint Paul has experienced an exponential increase of both new and reoccurring copper wire theft from street light fixtures both in city right of way and parks. The theft areas have drastically expanded from a few, regular targeted street lights in isolated areas to now impacting the entire city, including public and private infrastructure such as:

- Park trails and parking lots
- Major arterial and collector streets
- Traffic signals
- Ground access panels Utility vaults

- Heating and air conditioning systems Private businesses and
- EV charging stations Street lights
- The City of Saint Paul is not unique in dealing with rampant wire theft from public and private infrastructure. Other Minnesota cities, municipalities, and utilities are reporting increase in copper wire

thefts. In all parts of the country, wire theft is a growing issue.

New Proposed Copper Metal Legislation

The City of Saint Paul is leading new state legislation, alongside authors Sen. Pappas and Rep. Hollins. The proposed legislation, HF 4461/ SF 4455 would:



Require any person who is selling copper metal to have a license issued by the state. Persons licensed to perform electrical work are deemed to hold a license.



Allow residents and businesses to still recycle copper materials with scrap metal companies for free.

Why Are They Stealing Copper Wire? **Market Demand!**

Since 2020, the price for scrap copper metal has been at all-time highs. As of March 18, 2024, copper metal was valued at \$4.13 per troy ounce. According to scrapmetal.com, which tracks state averages paid for materials at scrap yards in Minnesota, bare #1 copper wire scrap is being purchased for an average of \$3.65 per pound.

What Can Residents and Businesses Do?

- 1. If you see something, say something. Call 911! Report suspicious behavior or activity around street lights, traffic signals, EV chargers, utility vaults, or private property. With the help of the watchful eves of Saint Paul residents and business owners, the Saint Paul Police Department has caught and arrested thieves.
- 2. Join Camera Watch. Registering your residential or business security camera and coverage information with the Saint Paul Police Department can help create safer neighborhoods for all. Your information is kept confidential. With this voluntary program the police department does not have access to your cameras but keeps a record of active cameras throughout the city. They may reach out to owners if and when needed.

The proposed legislation builds off the success of Minnesota's catalytic converter laws in drastically reducing the market demand and reselling of stolen materials. One significant challenge with copper wire and materials is, unlike catalytic converters, they are not registered and hard to track, especially when they are stripped of the insulation. This proposed legislation is gaining attention and support from other cities, municipalities, utilities, and labor organizations.



Saint Paul Continues to Address Ongoing Wire Theft

42K TOTAL STREET LIGHTS

37,000 street lights and 32,000 street light poles are maintained by Saint Paul Public Works and more than 5,000 street lights are maintained by Saint Paul Parks and Recreation.



\$1.2 million was spent by the City of Saint Paul in 2023 to repair and replace wire theft from street lights and signals in the public right of way and park facilities.

\$250K REPAIRS IN 2019

In 2019, Saint Paul spent approximately \$250,000 on wire theft issues, **more** than quadrupling the non-budgeted expenses for the city in five years.

2K OUTAGES

In February 2024, an estimated 2,000 street lights in Saint Paul parks were dark due to wire theft (does not include Public Works maintained street lights).

Comprehensive Strategy to Address Wire Theft:

- Maintaining and repairing damaged street lights and other public infrastructure
- Exploring engineering and infrastructure program changes where possible
- Increasing public education and engagement efforts, encouraging people to report all suspicious activity to 911
- Executing all law enforcement and prosecution strategies currently available
- Collaborating with local, state officials, residents, and businesses to support and pass new proposed state copper metal legislation

During the winter months, Saint Paul did not have a decrease in wire theft.

In 2024, Mayor Carter and Saint Paul City Council approved an additional \$500,000 for Saint Paul Public Works. This includes hiring a seasonal, full-time electrician crew who are dedicated to repairing damaged street lights and other infrastructure.

Reports of Wire Theft: January-December 2023



How Are We Preventing Theft?

City staff continues to try a number of different strategies to prevent and deter wire theft, including:

- Welding, epoxying, and banding access panels
- Using security bolts and screws to close and secure the access panels
- Installing new custom molded access panels, replacing broken or stolen panels
- Keeping streetlights on, or "daylighting," to keep the wires electrified during the daytime
- Using smaller gauge wire, which is less valuable for resale
- Labeling our wire with "City of Saint Paul" to identify the ownership for authorities and recyclers
- Silent alarms
- Exploring changing street light fixtures to solar and/or using overhead wires
- Considering changing street light fixtures to aluminum wiring
- Piloting high access panel street lights (coming in 2024)

To date, these efforts have not prevented wire theft. Some efforts resulted in additional damage to the street light fixtures and/or "moved" the thefts to another part of the city.

Dear Representatives Stephenson and Kotyza-Witthuhn and the Commerce Finance and Policy Committee:

I am reaching out to voice my opposition to HF4461 as it is currently written. I am speaking as an Eden Prairie resident who scraps copper with her partner as a method of reusing resources and recycling for small business income.

While copper wire theft is indeed an expensive crime, the bill as written creates a sweeping piece of legislation with unforeseen impacts on individual Minnesotans and small business owners throughout the state. In addition, it will remove the monetary incentive to recover and recapture copper metal scrap that will instead end up in the landfills, which creates a cascade of problems.

Instead of using the sweeping language of "scrap metal copper," I urge your committee to seek information on the 15-20 grades of copper that are currently used under ISRI.

For a copper license that will have the most impact on preventing wire theft, bare bright and burned wire could be regulated, as those two grades of copper are the only two that would remove marked insulation. Increased penalties on scrapyards that purchase stolen materials from questionable persons will also have a negligible impact on lawful recycling of copper by known members of the scrapping community. Municipalities could mark wire and provenance procedures could be followed at scrapyard level, similar to existing policies on the prohibition of purchasing railroad scrap.

The bill as written will affect tens of thousands of Minnesotans who legitimately recycle copper from demolition, small scale generation, home improvement projects, estate clean outs, and even recovering metal that's being discarded. The legislation as written includes categories such as computer cords, extension cords, holiday lights, silver plated copper, decorative items, pots and pans, and legitimately obtained wire and plumbing from leftover projects.

Many Minnesotans who recycle copper for income are not licensed electricians.
