## Members of the Minnesota Legislature:

We write to you, as dedicated members of Minnesota's conservation community, to express our support of the funding recommendations for the Outdoor Heritage Fund forwarded to you by the Lessard-Sams Outdoor Heritage Council (LSOHC) and packaged into HF4124, the Legacy Finance Omnibus bill.

This nation-leading Outdoor Heritage Fund was created when Minnesotans overwhelmingly voted in 2008 in favor of the Clean Water, Land & Legacy Amendment. With that vote, Minnesotans called for acceleration of conservation in Minnesota and full transparency of spending decisions and outcomes. The structure and process followed by the LSOHC has met and continues to meet those expectations.

This year's initial and supplemental funding packages were unanimously approved by the LSOHC before being submitted to the legislature. The recommendations contain 51 high priority conservation projects across the state, in addition to more projects that will be funded through the Conservation Partners Legacy Grant Program. The selected projects have been thoroughly vetted by the LSOHC through its competitive, public process, which received over \$373 million in requests and resulted in recommendations to you that total \$192.711 million.

In considering full approval of the recommendations, we encourage you to reflect on the following:

- 1. LSOHC members are citizens and legislators chosen for their expertise in conservation from a statewide perspective. The LSOHC is well-qualified to select projects that are urgent and most likely to return positive results from taxpayer investment.
- 2. The LSOHC's competitive grant application process is thorough, fair and transparent. It demands that proposals are well-designed, high-priority, science-based projects that address conservation goals enumerated by LSOHC and state plans.
- 3. The LSOHC adheres to a rigorous review process each year to determine its final recommendations for the Legislature. It prioritizes projects based upon several criteria, including urgency, reasonableness and ability of the proposer to achieve the outcomes.
- 4. The conservation projects recommended by the LSOHC are urgent and ready to implement.
- 5. LSOHC and the Minnesota DNR developed the Conservation Partners Legacy Grant Program, which sub-grants funding to smaller, community-level conservation projects. This popular Outdoor Heritage Fund program funds projects up to \$500,000.

The LSOHC package presented to you is worthy of your support. We are available as a resource to you and thank you for your support of conservation in Minnesota.

Chair Lillie,

On behalf of Friends of the Mississippi River, thank you for the work you and your committee have done in putting together the Legacy Budget Omnibus Bill (HF4124 DE2). We are particularly grateful to see that Article 2 (supplemental Clean Water Fund appropriations) includes the Clean Water Council's recommended funding levels, and does not include new funding line items.

As you know, the Clean Water Council works hard to prepare Clean Water Fund recommendations for the governor and legislature that best advance our shared clean water goals. The Council's process has produced supplemental recommendations that we strongly support, including:

- Minnesota Department of Agriculture (MDA): Nitrate in Groundwater (\$1.0 million) and the AgBMP Loan Program (\$3.402 million).
- Minnesota Pollution Control Agency (MPCA): River and Lake Monitoring and Assessment (\$326,000), Enhanced County Inspection/SSTS Corrective Actions (\$2.0 million), Chloride Reduction Grants (\$1.0 million) and the Continuous Nitrate Sensor Network (\$2.0 million).
- Department of Natural Resources (DNR): Fish Contamination Assessment (\$90,000).
- Board of Water and Soil Resources (BWSR): Great Lakes Restoration Initiative LAMP match (\$1.0 million), Critical Shoreland Protection Easements (\$4.0 million), Working Land and Floodplain Easements (\$4.434 million) and the Clean Water Partners Legacy small grants (\$2.0 million).
- Minnesota Department of Health (MDH): Drinking Water Contaminants of Emerging Concern (\$384,000) and the Southeast Minnesota Nitrate Response (\$2.79 million).
- The University of Minnesota: Stormwater BMP Performance Evaluation & Technology Transfer (\$1.0 million).

We look forward to working with you throughout the session to develop a final Legacy Budget Omnibus Bill that reflects the Council's recommendations.

MCGA is committed to addressing nitrogen challenges in southeast Minnesota and other vulnerable groundwater areas through partnerships, research, policy and best management practice adoption.

Dear Chair Lillie and Members of the Legacy Committee:

The Minnesota Ethnic Studies Coalition – which brings together nearly two dozen community, youth and education organizations – writes in strong support of the Omnibus Legacy Finance Bill (HF4124) and the funding it provides for Underrepresented Groups Cultural and Ethnic Studies.

Unlike other content areas such as Math, Literacy and Science, Cultural and Ethnic Studies curriculum and materials cannot be purchased from a curriculum and textbook service provider. HF4124 would allocate \$250,000 in fiscal year 2025 from the arts and cultural heritage fund to support the development of high-quality academic cultural and ethnic studies materials for communities that do not have adequate materials or who are underrepresented. This appropriation will directly support the development of materials that are co-constructed from the shared knowledge of educators, community experts, students and families.

As Minnesota schools become increasingly diverse, the need for culturally responsive and reflective curriculum is only more relevant. Studies show that when students see their own experiences and backgrounds within their curriculum, they become more engaged in learning, have a greater sense of belonging, and achieve better educational outcomes. HF4124 will invest in curricular resources to better meet the educational needs of all Minnesota students.

Thank you to Chair Lillie for inclusion of these funds in the Legacy Finance bill, and to Representative Sencer-Mura for recognizing this critical need and authoring the original legislation.

**RE:** Support Funding to Protect Minnesota's Aquatic Habitat from Invasive Carp

On behalf of the MN-FISH Coalition, I am writing to offer our strong support for the Lessard-Sams Outdoor Heritage Council funding recommendations, which include a recommendation to set aside funds for protecting the Upper Mississippi from invasive carp by beginning the process of partnering with the Minnesota Department of Natural Resources (DNR), U.S. Fish and Wildlife, and the U.S. Corps of Army Engineers to construct a barrier.

## Minnesota's outdoor recreational community and industry are at serious risk if invasive carp continue to move upriver and spawn.

MN-FISH has been actively working and meeting with the DNR over the last year, and a representative of the organization served on the DNR's Strategic Decision-making Working Group whose work was the basis for the updated Carp Management plan issued by the DNR earlier this year. On February 23, 2024, at a DNR Invasive Carp meeting with Commissioner Strommen and her team, our MN-Fish team presented a new collaborative approach to an Invasive Carp barrier at Lock and Dam 5 and best-practices from the invasive carp barrier implemented in Kentucky at Barclay Dam in 2019.

Research has shown that carp movement upstream is slow enough that it might be reduced to near zero (two percent) using a multi-component approach, including the construction of a barrier, continued commercial fishing by the DNR, and other means. A carp deterrent would be added to the lock, ongoing carp removal would be enhanced at this location, and engineers would examine whether and how to adjust spillway gate openings to allow even fewer carp to pass—while native fish passage would be facilitated using a native fish elevator.

This plan is supported by the scientific community. Key elements have been published in four peer-reviewed scientific publications and assessed by Barr Engineering Company, which also found it reasonable and doable. Four stakeholder meetings conducted by Barr have also been supportive.

Analyses suggest that adult invasive carp will be past lock and Dam 5 in just few short years and breeding in Lake Pepin—and then the St. Croix River—if no action is taken. There is just enough time to stop them if we act now. A plan exists that is capable of arresting would be the worst environmental disaster to strike Minnesota's waters since the zebra mussel.

We have appreciated working with Commissioner Strommen and her staff in finding solutions for Minnesota to respond to this environmental disaster. MN-FISH will be in support of the DNR's Invasive Carp Action Plan over the next ten years for prevention and management efforts in Minnesota.
