Dear Majority Leader Winkler:

I write to express my support for House File 1500. The safety of our public roads relies on the training, testing, licensing, and insuring of those who operate vehicles on them. Today, many people who live and work in our communities are barred from participation in these longstanding safety measures. We would all be better off if every driver were able to obtain a license, acquire insurance, and operate a vehicle on our roads with the sanction of the State. I therefore support this bill and the commonsense changes it would make.

The current prohibition on licensing of undocumented persons also poses other problems for enforcing our laws. Today, an undocumented person talking with a peace officer, whether at the scene of an accident, a traffic stop, or elsewhere, often has no government identification document to show that officer. This bill would help to solve that problem and would similarly aid other law enforcement efforts and criminal prosecutions by giving us more and better information about the people who live in our communities.

I have supported previous versions of this legislation, and subsequent studies in other states that have passed similar laws show improved public safety. Jurisdictions that allow for government identification for undocumented individuals show a reduction of uninsured drivers by almost 25%. Other studies have shown a significant reduction in the number of hit-and-run incidents and fewer fatal car collisions.

This bill is therefore good for public safety, good for the rule of law, and good for those seeking greater participation in our society and economy. I support it and would ask others to do the same.

We write to express our strong support for HF1500, which would enable residents of the state of Minnesota to obtain a driver's license or state identification card, regardless of immigration status. This is an important measure that will increase public safety and provide individuals who currently cannot obtain a driver's license with a measure of dignity by permitting them to participate in the lives of their families and community in a way that they currently cannot.

On behalf of the National Latino Peace Officers Association MN Chapter, we strongly endorse the Driver's Licenses For All legislation now before the Minnesota legislature.

As a police officer serving in the state of Minnesota, I know that licensed drivers are safer drivers. They have studied traffic laws to pass the written test and have practiced driving skills to pass the road test in order to get a license. They are less fearful of routine interaction with police officers and more willing and able to cooperate with law enforcement. Licensed drivers also are more likely to have insurance. After passing laws to allow undocumented drivers access to licenses, New Mexico saw its <u>rate of uninsured</u> drivers drop by 24%. Utah saw a similar drop of 20%.

To protect our community, we need the trust and cooperation of people in the community every day. That includes citizens and immigrants, adults and youth, documented and undocumented people. When people are afraid to talk to police or afraid to call and report a crime, that makes everyone in the community less safe.

Driver's licenses serve as identification for many kinds of routine interaction with police. That helps both police officers and the individual we are talking to, whether that individual is a crime victim making a report to us, a witness or potential witness in a case, or someone we are ticketing for going five miles over the speed limit or for having a burnt-out tail light. If someone has a driver's license for identification, these are all routine interactions. If someone does not have a license, these interactions can become frightening for the individual and frustrating for the officer.

As a Latino resident of Minnesota, I also know that Driver's Licenses For All will help families in our community. Many families are mixed-status: one or both parents may be undocumented, with children who are U.S. citizens. Parents need to be able to drive their

children to after-school activities or doctor's appointments. They need to drive to work and church and the grocery store.

Since our founding in 2002, the Minnesota Latino Peace Officers Association has worked, as our mission statement says, "To ensure equal opportunity in the administration of justice for our members and the communities we serve..." Before 2003, driver's licenses in Minnesota were equal opportunity licenses, available to anyone who was old enough to qualify and who passed the tests. I hope that this session of the Minnesota legislature restores that equal opportunity for all to get driver's licenses.

Base on the foregoing, we fully support Driver License For All in every possible way.

Members of the Minnesota House of Representatives:

As Ramsey County Attorney, I am concerned about the prevalence of unlicensed drivers in Minnesota. I understand that in 2002, there was a change in the rules governing driver's licenses which resulted in restricting driving privileges to only U.S. citizens and legal residents.

Statewide, nearly 20 percent of drivers do not carry insurance, according to the Insurance Federation of Minnesota. This percentage skyrockets for undocumented immigrants since one must have a valid driver's license to secure insurance. As most driving accidents are caused by unlicensed motorists, we clearly have a problem in our community that requires your attention as lawmakers.

Allowing all drivers to apply for a driver's license will ensure that everyone driving on our roads has demonstrated knowledge of our traffic laws and regulations, as this bill requires unauthorized immigrant drivers to pass both a written and driving test to obtain a license. It will also increase the likelihood of Minnesota drivers carrying auto insurance.

A number of states have prioritized public safety by passing laws allowing their residents to apply for a driver's license regardless of their status. I support this measure because I believe it will result in more licensed, insured drivers on our roads, enhancing public safety.

I fully endorse House File 1500 so we can make our state a better and safer Minnesota, and I hope the legislature will as well. Please feel free to contact me if I can be of further assistance.

Members of the Minnesota House of Representatives:

The Red Wing Police Department continues to work with all members of our community in the area of traffic safety. Since 2016 I have worked with members of our Hispanic community in the area of unauthorized immigrant driver's license. Many of our non-licensed immigrant drivers work on local dairy farms and have no other way to get to work, other than to drive illegally without a driver's license and in many cases without insurance. This places our legal drivers at risk, and also when a crash occurs, added costs or penalties for uninsured motorists, and expense to our legal drivers. Through support of H.F. 1500, unauthorized immigrant drivers would have the opportunity to demonstrate driver skill through written and driving testing, while also providing an opportunity to purchase vehicle insurance. Stanford University researchers conducted a study in California that concluded that allowing unauthorized immigrant drivers to obtain driver's license, did not increase the total number of accidents, but it did reduce the likelihood of hit and run accidents, which improved traffic safety and reduced costs for California drivers.

Additionally, when our officers cannot positively identify an individual, the officer will transport the unknown driver to the County Jail, for fingerprints and attempts to positively identify the individual. This removes officers from the street for added periods of time and prevents our ability to properly respond to calls for service from our citizens. By having a state issued driver's license, officers can positively identify an individual and issue the appropriate citation, allowing them to proceed on their way.

By allowing immigrant driver's license to be issued with proper identification and markings, that they are not to be used to establish residency for voting purposes, we can allow the immigrant

The Shakopee Police Department is committed to providing service with integrity and professionalism to our community. Our mission of community orientated policing is something our department takes pride in and continually strives to do our best at for all citizens of our city. I have been the Chief of Police of Shakopee for ten years and can say that H.F. 1500 will support our efforts within the community by affording every person the opportunity to obtain a driver's license.

Many of our non-licensed immigrant drivers work at area businesses and have no other means to get to work other than to drive illegally without a driver's license and most times without insurance. Unlicensed drivers not only endanger themselves but endanger society as a whole. If a crash occurs and the driver is unlicensed they more than likely do not have insurance. This law would help individuals who need to drive, learn the rules of the road through written and driving tests and safely learn how to operate a motor vehicle. Since it is mandatory for all licensed drivers in Minnesota to carry insurance, a decrease in uninsured motorists is a benefit of this law.

After passing laws to allow undocumented drivers access to licenses, New Mexico saw its rate of uninsured drivers drop by 24%. Utah saw a similar drop of 20%. Stanford University researchers conducted a study in California and concluded that allowing unauthorized immigrant drivers to obtain a driver's license did not increase the total number of accidents or fatal crashes, but it did reduce the likelihood of hit and run accidents, which improved traffic safety and reduced costs for California drivers. States that have allowed unauthorized immigrants to apply for a driving document have on average less traffic fatalities than states requiring either documented legal presence or a valid social security number. Allowing unauthorized immigrants access to driver's licenses would grant officers greater ability to enforce laws in immigrant communities. Additionally, H.F. 1500 will allow officers to positively identify an individual they encounter, issue the appropriate citation and allow them to continue on their way. The bill also enhances officer safety, creates fewer warrants, cuts down on wasted time trying to identify individuals and will have a positive impact on court administration. Not only will we see an added benefit of officer safety but also increased safety to the public. Licensed drivers are less likely to leave the scene of an accident or situation when law enforcement is called if they can confidently identify themselves, thus increasing cooperation with law enforcement.

By allowing immigrant driver's licenses to be issued, members of our community can safely travel to their jobs, help their children get to and from school, activities and appointments safely and with confidence.

Thank you for your time and also for considering this request, I recommend that you support this bill and allow every Minnesotan who chooses to, have the opportunity to obtain a driver's license.

Thank you for your leadership in supporting legislation that concerns the public safety of Minnesota. I understand that in 2002, there was a change in the rules governing driver's licenses which resulted in restricting driving privileges to only U.S. citizens and legal residents. I am aware that there is bipartisan legislation currently introduced that would reinstate the ability for all drivers in Minnesota to apply for a driver's license, regardless of immigration status.

Allowing all residents to apply for a driver's license will help ensure that more people driving on our roads pass an exam, demonstrating knowledge of our traffic laws, regulations and proficiency with behind the wheel testing. It can also improve the likelihood of more drivers carrying auto insurance through ease of obtaining it with a state issued license.

As law enforcement, it is important that residents have a state issued identification which includes their address. Under this law, residents will be able to obtain driver's licenses, which would allow officers to more easily identify the people they are encountering. At this time, officers must often work through interpreting a variety of documents from different countries and in languages other than English. This will also help law enforcement identify victims of crimes and assist in identifying people in medical emergencies or patients in traffic crashes.

A number of states have prioritized public safety by passing laws allowing their residents to apply for a driver's license regardless of their status. I understand that, according to the proposed legislation, the requirements to obtain a driver's license without a social security number will be very stringent. I support this measure because I believe it will result in more licensed, insured drivers on our roads and enhance public safety.

I support the passing of HF1500 so that we can make our state a better and safer Minnesota, and I hope the legislature will as well. Please feel free to contact me if I can be of further assistance.

Members of the Minnesota House of Representatives:

As Chief of Police for the City of Worthington, I write to urge support of House File 1500, a bill to allow all residents to obtain a driver's license or Minnesota identification card.

Worthington police officers encounter numerous inexperienced, undocumented drivers on a daily basis. As a result, our officers fulfil their commitment to public safety and issue tickets for various moving violations and driver's license related offenses. Worthington residents are victimized by a significant number of hit-and-run accidents, due in many circumstances to issues related to unlicensed, uninsured drivers. Investigations of these matters consume time, energy, and resources from law enforcement, prosecution, and courts for simple traffic offenses that compound into major problems for the violators.

Most of our local, unlicensed drivers lack a basic understanding of traffic laws and the justice system in general. Locally, public transit opportunities are limited, so people without other means find themselves having to drive regardless of the consequences. We police in an unbiased manner and our department has done many things to ease the community's perceptions and fears, but it remains difficult due to this constant issue.

From a public safety perspective, I argue we need to look to the root of the problem and make an effort to provide education related to the responsibilities of owning and operating a motor vehicle. If a level of understanding can be achieved, and limited drivers' license issued, our streets would be safer and more drivers would be insured. I'd rather see an educated, insured motoring public, than continue with our current circumstances.

I'd hope that the licensing of undocumented people will be the first step in a process which aids in a legal path to citizenship. This should be a process that improves current issues related to identity fraud, not one that complicates it.

Members of the Minnesota House of Representatives:

In rural Minnesota, we all need to drive—to work, to school, to the grocery store, or even to our favorite fishing spot. Since 2003, many in our community have had a problem with driving. That's when politicians in St. Paul changed decades of Minnesota law to prevent undocumented immigrants from getting Minnesota driver's licenses.

This year, we have a good chance to change that law back, with the Driver's Licenses for All bill now making its way through the Minnesota legislature. The bill, co-sponsored by our own representative Rod Hamilton (R-22B), has had packed and enthusiastic hearings in the Minnesota House.

First and foremost, this Driver's License bill is about improving safety. According to Chief of Police for the City of Worthington Troy Appel, local officers encounter numerous undocumented drivers every day. Making licenses available to undocumented drivers will mean that they learn all the rules of the road before they take driver's tests and earn their license, creating a safer environment for all. Further, providing reliable identification documents issued by the state will allow local law enforcement the ability to identify who they are working with, during encounters that range from routine to emergency. Chief Appel joins me in supporting this bill to improve public safety.

For mixed-status families, issuing licenses to undocumented immigrant parents also means giving U.S. citizen children safer access to essential services like education and healthcare. For these children, living in uncertainty about whether their parents will remain in the United States may lead to life-long trauma.

In addition, making licenses available to undocumented drivers will also increase the number of drivers on our roads with auto insurance. After passing laws to allow undocumented drivers access to licenses, New Mexico saw its <u>rate of uninsured drivers drop</u> by 24%. Utah saw a similar drop of 20%. Simple economics tells us that fewer uninsured drivers on the road means lower premiums for everyone.

Immigrants have helped keep Worthington growing and vibrant, instead of shrinking like too many other small towns in Minnesota. Immigrants are our neighbors and valued community members. They work in agriculture and industry, they open businesses and provide jobs, and they help to keep Worthington thriving.

I care about the safety of our roads and the well-being for all Worthington residents. Licensing all drivers, regardless of immigration status, is a responsible way to increase safety and security for all.
