This is part of why we strongly support and recommend the passage of HR 1500. We feel this measure is long overdue. For years our Local has worked with other Labor unions, the Minnesota Chamber, Law enforcement, faith denominations & community organizations. We are one community, one State and one Nation formed by immigrants.

All these organizations have strongly supported drivers licenses for all. Many members of Law Enforcement have strongly argued that allowing drivers to be receive licenses promotes public safety. As you are aware the proposal in front of you will ensure that drivers are trained, tested and able to obtain insurance. Drivers who have a valid drivers license can identify themselves and are more willing to interact with police and other government agencies. We feel our law enforcement officers should not have to waste tax dollars pursuing these residents for driving without a license, when there are far more important law enforcement priorities to expend limited resources on other.

Researchers have demonstrated that expanding access to drivers' licenses leads to access to better job and improvements to the economy. People who have the mobility to find a better job can receive a higher paycheck and contribute more in taxes.

UNITE HERE Local 17 believes that passing HR 1550: will reduce the hit and run accidents and fatal accidents by allowing these drivers access to training and testing on driving skills. We believe it will increase the number of drivers who obtain car insurance, allowing the cost of car insurance to decrease FOR ALL drivers. When drivers are allowed the opportunity to have a valid driver's license, they are also then able to purchase vehicles. This boost in sales will in turn have a positive economic impact and help to strengthen the economy.

In addition, by issuing drivers licenses to the thousands of drivers that would be eligible, regardless of their immigration status, Minnesota will generate additional dollars in issuance of the increased number of drivers licenses and in vehicle registration fees. They will then have the option to become organ donors which then has a healthy impact on the over-all well-being of our community.

UNITE HERE! Local 17 strongly urges you to implement HR 1500, By doing so you will be ensuring that all drivers have the ability to be trained, tested, insured and held accountable, law enforcement funds can be directed to more important priorities, and additional money will be put back into our state in multiple ways which will help to strengthened the economy.

It is these bedrock Minnesota values that underscore why we are in full support of HF1500, the Freedom to Drive bill.

We want our roads to be safe for everyone. We want all drivers to have the ability to take a test and get insurance so if something bad does happen it can be resolved. But the current law doesn't allow these basic steps for thousands of Minnesotans.

When this law was changed in 2003, it made our neighbors, co-workers, friends and families feel unwelcome. We believe Minnesota is a better than this.

Parents will always make sure their kids can get safely to school during the polar vortex. People will always drive their parents to the hospital if they are having health issues. Minnesotans will always drive to work to make sure they have enough money to pay their bills and provide for their families. The current law doesn't change these facts, it just denies people the chance to go through the process of testing and getting a license like everyone else.

We often are on the opposite side of issues from the Chamber of Commerce, but the Freedom to Drive bill brings together labor unions, business groups, law enforcement, faith leaders and community groups. We know a small group of people in power will try to divide our diverse, bi-partisan coalition. But we believe Minnesota is ready to show that this bill is one where common sense is stronger than divide and conquer.

Right now there are Minnesotans who just want to do what is right, but our laws prevent it. Allowing every Minnesotan – white, black or brown, rural or metro – the chance to get a driver's license would mean the world for families across Minnesota who are currently denied the chance to get one.

We urge you to pass the Freedom to Drive bill so our roads can be safe for ALL of our families.

Dear Representative:

We are writing to you with our strong support of HF 1500, the proposal to allow drivers' license access for thousands of Minnesotans currently barred from the system. This proposal would give thousands of people the freedom to share our roads and participate in our state's communities with dignity and safety.

Drivers' licenses for all would make our streets safer, plain and simple. There are two options when considering HF 1500: should we allow undocumented Minnesotans to take the license exam, purchase car insurance, and drive on our roads; or, should we continue with the current system in which undocumented Minnesotans do not take the exam, do not purchase car insurance, and drive anyway. The choice is clear.

HF 1500 will also allow undocumented Minnesotans to navigate their communities with less fear that they will be detained by law enforcement that could result in expensive fines, lost income from employment, and possibly deportation. Regardless of what some may feel on whether or not undocumented people should live in Minnesota, the fact of the matter is that almost anybody who lives in Minnesota needs to use a car on a daily basis to drop kids off at school, go to work, buy groceries, go to a place of worship, and any number of other essential tasks to thrive in our communities, and no one should be forced from participating because of their immigration status.

At AFSCME, we work to embody respect, dignity, compassion in all the work we do on the basis of unqualified equality, because of race, creed, color, national origin, religion, sex, age, sexual orientation, gender identity or expression, disability, or political belief. HF 1500 more than meets that threshold, and we urge you to vote green for drivers' licenses for all.
