RE: Support of H.F. 1500

Dear Members of the Minnesota House of Representatives:

The Advocates for Human Rights supports H.F. 1500, which will restore access to driver's licenses and state identification to all Minnesota residents. The Advocates for Human Rights is a nonprofit organization headquartered in Minnesota that engages volunteers in protecting human rights in our home community and in partnerships around the globe. For more than 35 years The Advocates has represented people fleeing persecution and torture as they seek asylum in the United States. Last year, The Advocates provided free legal assistance in more than 1000 cases, 85% of which were represented by pro bono attorneys.

Things have changed since the 2003 regulatory ban on access to driver's licences was enacted. Today, the availability of REAL ID-compliant licenses makes the 2003 ban redundant, confusing, and at odds with federal law. More importantly, the 2003 ban excludes some Minnesotans from our communities, resulting in unnecessary anxiety and trauma for themselves, their families, and their communities.

Not only does the 2003 driver's license ban send a message of exclusion, it places a severe and unwarranted burden on people. Witness the experience of one of the clients of The Advocates for Human Rights, as he struggled to retain his driver's license – which he needed to get to medical appointments – even after being granted asylum:

<sup>&</sup>lt;sup>1</sup> Because of the statutory requirement that the 2003 driver's license ban regulations remain in effect even after the creation of REAL ID-compliant licenses, Minnesota now has two separate and inconsistent lists of which non-citizens qualify for driver's licenses. Minnesota's 2003 ban, enacted prior to the federal REAL ID Act, attempted to identify those non-citizens who are "lawfully present" in the United States. The complexity of federal immigration law and procedures, however, left many people who are "lawfully present" with no way of showing that to DVS agents.

1.	2012	Client files for asylum in the United States.
2.	8/23/2018	Immigration Judge grants asylum. DHS/ICE attorney reserves appeal.
3.	9/23/2018	Immigration Judge's grant of asylum becomes final when DHS/ICE does not appeal, but DHS/ICE fails to send the A-file to USCIS for I-94 processing so no new I-94 card is produced.
4.	10/25/2018	Client goes to USCIS Infopass appointment to inquire with USCIS about the status of his I-94 card. He is told to wait.
5.	11/26/2018	Minnesota DMV issues letter alerting client his driving privileges will be canceled if he does not provide "new or extended residency document, or an INS receipt of application for extension of legal presence document."
6.	12/4/2018	Client goes to a second Infopass appointment to inquire with USCIS. He is told to continue waiting.
7.	12/2018	Client provides copy of immigration judge order as proof of asylum status to DPS/DVS. DVS says he needs an "I-797C, Notice of Action" and does not update status check date.
8.	1/14/2019	Client seeks help from The Advocates for Human Rights. A staff attorney prepares variance request for DVS.
9.	1/15/2019	Client takes variance request to DVS. DVS rejects variance as insufficient and continues to require an I-797C.
10.	1/16/2019	The Advocates staff contacts USCIS to inquire about status of I-94 process. USCIS responds that they do not have the file. They will request it from the ICE Office of Chief Counsel and "take appropriate action" once it is received. New work permit application is submitted based on (a)(5) asylee category.
11.	1/22/19	Client receives notice from USCIS to pick up new I-94 on 1/24/19.
12.	1/24/2019	Although the client is now authorized to work incident to his status as a person granted asylum, the driver's license "status check" date, which was determined on the work permit that was based on his pending asylum claim, means the license is no longer valid. Client is not currently working but needs to drive to doctor appointments.
13.	2/25/19	USCIS approves EAD.

The 2003 driver's license ban will soon exclude several thousand Liberians who have lived in Minnesota under either Temporary Protected Status or Deferred Enforced Departure. First designated for protection in 1991, Liberian DED is scheduled to expire on March 31, leaving those Liberians with "status check" driver's licenses unable to drive.

By passing H.F. 1500, the Minnesota Legislature can make sure that people are not caught in a bureaucratic catch-22.

H.F. 1500 does more than overturn the outdated 2003 driver's license ban. It takes an essential step toward ensuring that all Minnesotans are included in our community. It recognizes that kids should be able to get to the doctor when they are sick, that parents should be able to get to their children's school for conferences, and that families should be able to go to church together. It recognizes that the more than 30,000 children born in Minnesota who live with an undocumented parent have a right to the integrity of their families.

In 2014, The Advocates for Human Rights reported<sup>2</sup> that immigrants and refugees face barriers to belonging in Minnesota because of discrimination and social distance and that thousands of undocumented Minnesotans and their families live excluded from the community, in constant fear of deportation, and vulnerable to human rights violations.

Minnesota has an obligation to ensure that all people, regardless of where they were born, enjoy safety and security, access to justice, the protection of the family, and the ability to meet their basic needs. We urge you to vote for H.F. 1500.

Dear Members of the Minnesota Legislature,

We are writing on behalf of undocumented Black immigrants in Minnesota to urge you to support restoring access to driver's licenses for undocumented Minnesotans by voting in favor of HF 1500.

Minnesota is home to a large Black immigrant populations in the United States with over 200,000 living here. We continue to contribute to the economy and cultural landscape of the state- from the Twin Cities, the Metro and to Greater Minnesota. We are business owners, union workers, nurses, doctors, nurses, engineers, lawyers, janitors, farmers, etc. Most importantly, we are a part of the fabric of Minnesota. This is home for us.

Driver's licenses are important to our undocumented population. Black Minnesotans are 214 times more likely to be pulled over than others due to the over-policing of Black people in the U.S¹. Our point here is that Black immigrants are more likely to be pulled over and placed in deportation proceedings than any other immigrant population. This is why the Black Immigrant Collective supports #freedomtodrive which is campaigning for Driver's Licenses for All legislation in partnership with DFL legislators. While it will not stop profiling, a Driver's License would give our community some freedom to move around with dignity. We are grateful that an anti-discrimination clause exists that will offer some protection to our community.

Black immigrant undocumented communities in Minnesota are putting themselves at risk every time they want to do what most of us take for granted like driving to the grocery store. The passage of this bill will allow many in our communities to move freely without

Esteemed Members of the Minnesota House of Representatives

We write with great urgency in support of the passing of HF1500 (driver licenses for all). As scholars who research immigration, education, labor, and housing rights we see this bill as an important step towards social justice for Minnesota residents.

To date, roughly 82,000 people in the state of Minnesota are eligible for state IDs or driver licenses but cannot obtain one under the state's present conditions. Prior to 2003, undocumented Minnesota residents, many of whom have lived in the state for decades, were able to receive valid state IDs and driver licenses. For over fifteen years, since this policy change, Minnesota residents have been denied proper identification.

Access to driver licenses is a public safety issue. Already twelve states and the District of Columbia have passed similar legislation. Having a valid driver license contributes to everyone's public safety. All residents' quality of life improves when everyone knows the rules of the road and traffic regulations.

Licensed drivers contribute to Minnesota's economy. For many Minnesota residents driving is not a choice, but one of necessity. Having a valid license would ensure Minnesota residents the safe access to their employment sites. It would also enhance the economic access for other family members, often who live in "mixed-status" households, who rely on other members for transportation. Moreover, Minnesota would see an increase in state revenue from the application fee.

Most importantly, driver licenses for all builds stronger Minnesota communities. While this bill directly impacts undocumented Minnesota residents, it also supports the elderly and homeless. When everyone in our state has access to driver licenses, people are able to be more mobile and build deeper relationships with their broader community. Our social fabric strengthens when everyone has access to travel to attend and participate in the cultural, educational, and employment opportunities within our state.

We urge you to pass this important legislation for all Minnesota residents.

Members of the Minnesota House of Representatives:

I am writing this letter in support of HF 1500, the Driver's Licenses for All bill introduced by Majority Leader Ryan Winkler. I strongly believe that all Minnesotans should have the ability to apply for state driver's licenses and identity documents regardless of immigration status.

Before 2003, all Minnesota residents had access to state-issued driver's licenses. A change in law implemented by then-Governor Tim Pawlenty made driver's licenses out of reach for immigrants unable to prove valid immigration status.

As an immigration legal services provider, I am acutely aware of the precarious environment in which immigrants currently live. While immigration policies continue to change at the federal level, many of our Minnesota neighbors are in danger of losing their status at a time when, according to court records, statewide ICE apprehensions have increased by 67 percent. This means that an immigrant's encounter with law enforcement for something as mundane as a burned out tail light could begin a perilous journey that could end up in their removal from the United States and the break-up of their family, and the loss of their homes and their livelihoods.

Our immigrant neighbors have become integral to the fabric of our communities. Of the 95,000 undocumented immigrants in Minnesota, more than half have lived in the state for more than a decade. In that time, they have established deep roots in the state and have become intrinsic members of their communities. Many of these individuals are the parents of U.S.-citizen children whom they need to drive to school and to doctor's appointments. The uncertainty in which many children find themselves can lead to stress and life-long trauma.

Supporting HF 1500 would bolster public safety. By requiring all Minnesota drivers to pass a driving test and to obtain auto insurance, we would ensure safer roads for all and decrease auto insurance premiums. Further, law enforcement agents and first responders would be able to identity people during the course of their duties, during which, sometimes seconds count.

Again, I urge you to support HF 1500. It is time that Minnesota joins 12 other states and the District of Columbia in providing this vital document for our neighbors.

Dear Representatives:

We are Asamblea de Derechos Civiles de Minnesota (Minnesota Assembly for Civil Rights) and we support the Freedom to Drive Minnesota Bill.

Asamblea is a statewide, faith-based, non-profit organization which organizes immigrants from predominantly Latino congregations to build power for changes in the immigration system and the underlying political and economic structures behind it. As such, we support the Freedom to Drive Bill for many reasons:

First, the bill will improve the lives of the people we represent. Hard working, undocumented Minnesotans cannot have access to a test to obtain driver's license, but must still get to work, attend to the needs of our children and participate in our community's activities.

Second, we, hard working Minnesotans contribute to the state through our work, and through the taxes we pay. Like other Minnesotans, our taxes go to creating a stronger state infrastructure. It only makes sense that we should benefit from the improvements made to our roads and bridges through our taxes.

Third, giving us the opportunity to earn a driver's license will make our state safer by ensuring that all people driving have been adequately trained and tested.

Fourth, licensing more drivers means a boost to our economy. More licensed drivers means more money in the state coffers, more money to insurance agencies and more money to car dealerships.

We would never jeopardize that path by trying to vote. We are fully aware that such an action would deny us the right to citizenship forever.

Women's March Minnesota strongly supports HF 1500 - The License Access and Public Safety Act.

Before 2003, residents of Minnesota could obtain driver's licenses regardless of immigration status. We implore you to return this privilege to people who have lived in Minnesota for decades and ask that you extend it to those who are recent residents.

Approximately 82,000 residents of Minnesota are eligible for a driver's license but cannot get one because they are undocumented immigrants. Many of these 82,000 Minnesota residents have family here including US born children, so this law can benefit hundreds of thousands.

We have heard stories from mothers who could not take their children to doctor's appointments or emergency rooms as public transportation continues to be insufficient or unavailable in most of Minnesota. There are multiple stories from women business owners who have lost customers because of lack of transportation. Young drivers tell us they are unable to move to attend college because they are their family's source of transportation.

Women's March Minnesota recognizes the value to our state when every driver receives training, passes a driver's test and purchases car insurance. The 12 states and District of Columbia that already allow undocumented immigrants to obtain driver's licenses have seen these benefits.

We urge the Minnesota House to vote yes regarding HF 1500 - The License Access and Public Safety Act.

To the Members of the Minnesota Legislature,

On March 14<sup>th</sup>, 2019, the Northfield Human Rights Commission approved unanimously a motion to present a resolution of support of the driver's licenses for all to the Northfield City Council. On April 2<sup>nd</sup>, 2019, the Northfield City Council will vote on a resolution in support of the bill that will restore the access of all Minnesotans to obtain a driver's license.

The resolution at the Human Rights Commission followed several key points in this discussion:

- It is time to restore the driver's licenses for all Minnesotans. The reasons given in 2003, to increase the security of people in the state, following the terrorists attack of 9 11, have proven not beneficial for the state.
- In rural areas such as Northfield, people depend heavily on their cars to run basic errands and even without driver's licenses people drive. In many cases drivers have car insurance but no driver's licenses.
- Access to driver's licenses for everybody in the state will create safer roads for all Minnesotans. New Mexico passed a similar law and there was an increment of 24% of insured motorists.
- We cannot fix the immigration issues at the federal level but as states we have ways to make changes that will address major disparities and injustices committed against immigrants.
- We should care equally for everybody regardless of their immigration status, country of origin, religion, creed, race, ethnicity, disability, sexual orientation, gender identity, age or disability.

We hope this is the year that a more than a decade long demand from many groups across many different communities in the state is finally met and driver's licenses will again be issued to all Minnesotans as it was before 2003.

Within the larger community there are pockets of immigrants, low income people and people of color striving to thrive in a mostly white middle class town.

Neighbors United is led by immigrants from different countries. As part of our work we know how important it is to be able to have access to jobs and opportunities and contribute to the local economy. But the simple action to drive a car to a job place or buy groceries is for many of our neighbors a complicated proposition.

Before the terrorists attacks of 9 11 everybody in Minnesota was able to drive a car with a driving license. After 9 11, and the country's push to strengthen people's security undocumented immigrants cease to have access to driving licenses. Many great policies were enacted after the worst terrorist attacks in this country's modern history such as not allowing the airplanes cockpit doors to be accessible to passengers. The Pawlenty executive order in 2003, on the other hand, was a policy that did more harm than good by putting an end to driving licenses for all.

Legislators probably thought at the time that the move was necessary and yet didn't account for the many people that need to drive around the state to work, buy essentials, take care of sick family members or take children to their schools or activities. Perhaps they thought they wouldn't drive anymore. The reality is that people continued to drive, especially in rural areas like Northfield where public transit is almost nonexistent. They continued to drive and developed an even deeper distrust and fear of the police. Many drivers still carry the expired licenses in their wallets.

The argument to wait for the federal level to fix the immigration laws and really acknowledge the many people needed to sustain the US economy is not a valid one. We've been waiting decades for a change that never seems to come. The result is a large number of drivers without driving licenses in the Minnesota roads making everybody less safe. States around the country are taking matters into their own hands and doing what the federal government is not capable of doing yet. States are granting driving licenses back to all its residents, twelve states have done it already.

Minnesota could become soon another state to allow everybody to obtain a driver's license. It is a matter to acknowledge that immigrants are part of the economy, work, consume, pay taxes and drive. Having everybody on the road with a driving license and car insurance is a benefit to everybody. Safe roads are much needed in the instances of a crash. Many undocumented immigrants drive with car insurance even without driving licenses. They also want to be safe on the road.

Hopefully soon everybody will be able to drive with a driver's license as the bill proposed, HF1500 makes its way through the House and does the same with the Senate. A law allowing everybody to obtain a driving license will bring peace of mind for all drivers and people in Minnesota.

Neighbors United supports the driver licenses for all campaign and proposed bill and hopes this is the year it is finally signed into law. It's been over sixteen years of a fight to restore driving licenses for all. It is time Minnesota implements again common sense policies for the benefit of all residents in the state.
