Members of the Minnesota House of Representatives:

Cooperative Network is one of the largest associations of its kind in the country and serves more than 250 member-cooperatives. Our members are owned by millions of residents throughout Minnesota and Wisconsin and include member-owned farm supply, dairy marketing, livestock marketing, financial, health care, mutual insurance, processing, electric utility, housing, food, and worker-owned cooperatives, among others.

Cooperative Network's membership includes cooperatives that rely on members of the immigrant workforce community who would benefit from passage of House File 1500, which would allow undocumented individuals to operate vehicles legally on Minnesota's roadways. This legislation includes critical requirements that these individuals complete driver's license training, testing and general license requirements, as well as securing proper and adequate insurance.

Agriculture is Minnesota's largest basic industry, with about one-fourth of the state's labor force employed in agriculture or agriculture-related industries. Cooperatives are integral to Minnesota's agricultural economy, as well as the state's economy. Our member cooperatives deliver commodities, fuel and inputs to our member-owners throughout the state, as well as to markets throughout country and world.

Cooperative Network's member-driven resolutions support comprehensive federal immigration legislation that will provide a pathway to improving the stability of a year-round labor workforce in rural America. Absent of any immigration reform legislation passing on the federal level, House File 1500 is a state-level answer that will assist our cooperative members and their workers to sustain and grow the agricultural production and processing footprint in Minnesota.

Members of the Minnesota House of Representatives:

Minnesota businesses value the contributions of immigrants to our state. Their roles as workers, entrepreneurs and consumers are important to the development and growth of our economy and our communities.

Our organizations support HF 1500 (Representative Winkler) for workforce and public safety reasons:

- Our labor participation rate is second highest nationally. Demographics indicate that as our population continues to age and as our economy grows, Minnesota will not have the numbers of people needed to meet labor market needs. Immigrants are a key to this challenge.
- In addition, Minnesota employers rely on immigrant workers to serve their customers. To do this safely, workers should complete drivers' license training, testing and licensing requirements, including securing insurance. We believe this will make roads safer for all drivers.

We appreciate the proposed amendments that address concerns regarding making the non-voting notation even more prominent on the license; the removal of non-discrimination provisions relating to the Minnesota Human Rights Act; and adjusting the term of the license from four years to two. These amendments improve the bill.

As we wait for a comprehensive solution to immigration on the federal level, we recognize that the state also has a role in certain state based issues. H.F 1500 addresses a state based public safety and employment concern by requiring immigrants to obtain Minnesota drivers' licenses.

Members of the Minnesota House of Representatives,

I am to write to express our strong support for HF1500, my name is Gustavo Rivera, I am 43 years old. I have lived in Minnesota since 1996. I am married and have Three Children who are United State Citizens. On April 4, 2012, I opened a small business of used vehicles in the city of St Paul. The reason I opened my business was to be able to help and support my community and individuals during the process of buying and selling vehicles. By speaking in their preferred language Spanish, customers will feel confident and safer.

On October 31, 2018, I was notified by the Department of Motor Vehicle (DMV) located on the second floor of Sears Store that dealers could no longer sell and transfer vehicle titles to people holding a Foreign Identification or Passport. 90% percent of my clients are from the Hispanic Immigrant Community. When I learned this, I knew that I had a serious problem, since we could no longer make sales to those who do not have a U.S. identification or passport.

I understand this law was made in 2002. It was not implemented until October 31, 2018. I do not understand why it took the DMV 16 years to begin to enforce the law that now prevents me from doing my job. For the past 7 years I have been able to sell and transfers vehicle titles to people who have foreign identification or foreign passport.

At this time my business is being negatively affected by this law. I can no longer sell vehicles to my previous customers if they do not have a proper state identification or passport. There for, I am asking you to support HF1500, so that I will be able to carry out my business and continue to support Minnesota's economy as it continues to grow.

We strongly urge the House of Representatives to pass HF1500, as it represents an important and responsible way to increase safety and security in Minnesota.

Dear Minnesota House of Representatives,

Sunrise Banks is a \$1 billion commercial bank located in the cities of Saint Paul and Minneapolis, focused on community development of the state's urban centers. The bank is privately owned by the Reiling family who reside in the community.

Over the past year, the bank has been working closely with the city of Minneapolis on crafting a bank-acceptable Municipal ID card; following a number of meetings and detailed consultations, Sunrise and the city arrived at an acceptable card-one that can be utilized in the provision of daily banking services.

Today, the bank supports the general concept introduced by Minnesota House File 1500 that will further assist all Minnesotans with other identification issues and problems, specifically relating to Driver's Licenses.
