### Overview

Provides that executive branch advisory groups expire June 30, 2009, unless specified otherwise. Repeals the laws establishing groups whose statutory authority appears to have expired under the June 30, 2003, sunset date in current law.

### Article 1

#### General Laws Governing Boards and Advisory Groups

- 1 Expiration date.** Establishes a default expiration date of June 30, 2009, for advisory councils and committees. Requires the Secretary of State to notify the primary appointing authority or the chair of a group prior to the group's scheduled expiration.

## Article 2

### Repeal of Expired Advisory Groups

Repeals laws governing advisory groups whose authority may have expired under the June 30, 2003, expiration date established in Minnesota Statutes, section 15.059. Provides that certain committees continue. The section-by-section summary below lists the name of the group being repealed in each section.

- 1 **Assistive technology.** Strikes reference to the Governor's advisory council on technology for people with disabilities (the committee is repealed in the repealer section of the bill), and provides that the Department of Administration is the responsible agency to carry out responsibilities under the federal assistive technology act.
- 2 **Corrections Industries Purchasing Task Force.**
- 3 **Small Business Procurement Advisory Council.**
- 4 **Seed Potato Certification Task Force.**
- 5 **Public Employee Long-Term Care Insurance Advisory Committee.** (Also dealt with in repealer section)
- 6 **Land Use Advisory Committee.**
- 7 **Arts Board Advisory Committee.** Provides that the Arts Board authority to appoint advisory committees does not expire.
- 8 **Breeder Fund Advisory Committees.** (Several)
- 9 **Mental Health Services Planning Council.**
- 10 **ICF/MR Facility Advisory Committee.**
- 11 **Commission serving deaf and hard of hearing people.** Provides that this commission does not expire.
- 12 **Public Employees' Defined Contribution Plan Advisory Committee.**
