Overview

This bill, if passed, would require biannual child welfare workforce stability studies, annual Minn-LInK child welfare studies, modifications to the Child Welfare Training System, and a child welfare caseload study.

Proposes coding for § 260C.81.</p> <p>(a) Requires the commissioner of human services to partner with the University of Minnesota Center for Advanced Studies in Child Welfare to conduct a workforce stability study, examining (1) workforce intent to remain in child welfare, (2) statewide turnover, and (3) barriers to retention.</p> <p>(b) Requires that the study be completed by June 30, 2021, and repeated biannually, and requires a report by December 1, 2021, and biannually thereafter.</p> <p>(c) Requires the commissioner, after each study is complete, to work with the Child Welfare Training Academy and stakeholders to develop strategies to stabilize the child welfare workforce.</p> <p>(d) Appropriates money in fiscal year 2021 and biannually thereafter for these studies.</p> |
| 2 | <p>Minn-LInK study. Proposes coding for § 260C.82.</p> <p>(a) Requires the commissioner of human services to partner with the University of Minnesota's Minn-LInK statewide data project to conduct an annual study on characteristics, experiences, and outcomes of children and families in the child welfare system.</p> <p>(b) Requires the commissioner to submit a report of the research results.</p> |

| 3 | <p data-bbox="355 352 727 380">Child Welfare Training System.</p> <p data-bbox="453 401 1365 499">Subd. 1. Modifications. (a) Requires the commissioner of human services to modify the Child Welfare Training System and rename it as the Child Welfare Training Academy.</p> <p data-bbox="453 537 1390 600">(b) Specifies that the Academy will be administered through five regional hubs, each of which will provide training targeted to the needs of the region.</p> <p data-bbox="453 638 1333 737">(c) Specifies that the Academy will use training methods best suited to the training content, employing national best practices in adult learning. Lists methodologies to be used.</p> <p data-bbox="453 774 1422 915">(d) Requires each child welfare worker and supervisor to complete a certification, including a test and skills demonstration, at the end of initial training and biannually thereafter. Requires the commissioner to develop ongoing training requirements and way to track certifications.</p> <p data-bbox="453 953 1414 1052">(e) Requires each regional hub to have a regional organizational effectiveness specialist trained in continuous quality improvement strategies, who will provide organizational change assistance to counties and tribes.</p> <p data-bbox="453 1089 1398 1152">(f) Specifies that the Academy must include training and resources that address worker well-being and secondary traumatic stress.</p> <p data-bbox="453 1190 1406 1289">(g) Specifies that the Academy will serve county and tribal child welfare workers and supervisors, and staff at private child placement agencies that partner with counties.</p> <p data-bbox="453 1327 1398 1503">Subd. 2. Partners. Requires the commissioner to partner with the University of Minnesota to administer the workforce trainings. Requires the commissioner to partner with one or more other agencies for consultation, subject matter expertise, and capacity building in organizational resilience and workforce well-being.</p> |
| 4 | <p data-bbox="355 1560 711 1587">Child welfare caseload study.</p> <p data-bbox="355 1604 1406 1703">(a) Requires the commissioner of human services to conduct a child welfare caseload study by July 1, 2020, collecting data on the number of child welfare workers in the state and the amount of time they spend on different aspects of their work.</p> <p data-bbox="355 1740 1292 1801">(b) Requires the commissioner to submit a report on the results of the study by December 1, 2020.</p> |

| 6 | Appropriation. (a) Appropriates money in fiscal year 2020 for the Child Welfare Training Academy. (b) Appropriates money in fiscal year 2020 for the child welfare caseload study. |
